Applications are invited for admission to three year vocational degree programme B.Voc (Retail Management) and B.Voc (Tourism Management) with multiple exit points approved and recognized by UGC at par with other Bachelor degree programmes.

Eligibility: The eligibility condition for admission to each B.voc programme shall be 10+2 or equivalent in any stream/ NSQF Level.

DURATION: The course is of three years duration with option to exit as explained below:

Award	Duration	NSQF level
Diploma	1 year	5
Advanced Diploma	2 years	6
B.Voc Degree	3 years	7

The admission for the vacant seats will be made on the basis of academic merit of qualifying examination for each above said course or by entrance test (which will be held at Jammu) if the number of admission seekers is more than three times the number of seats.

The duly filled in application form should reach to the office of Head, HRM & OB Temporary Academic Block, Sainik Colony, Jammu-180011 on or before 26th August 2016, with requisite documents and a draft of Rs 250/- (Rs100/- from students belonging to SC, ST, and PWD), in favour of Finance Officer, Central University of Jammu payable at Jammu.
