Sub: Representation of candidates - Screening/Scrutiny of forms for the post of **Library Attendant** – Reg.

In response to Screening Committee Recommendation cited at 2, the University received following representations, which are considered/ disposed of as below:

1. **Request of Ms. Isha Kumari D/o Sh. Gian Chand (Sl.No.16):**

Ms. Isha Kumari vide request letter dated 29.05.2017 received dated 29.05.2017 submitted that her application form was earlier rejected on the ground of merely not signed the application form. The Committee considered her form as approved by the Competent Authority. Hence, **the candidate is eligible for the post.**

2. **Request of Sh. Dilip Kumar Malakar S/o Sh. Subash Chander (Sl.No.21):**

Sh. Dilip Kumar Malakar vide e-mail dated 2nd June, 2017 submitted the Experience Certificate dated 2nd June, 2017. The Committee considered his form and found that the candidate has not completed 01 year experience as per the requirement of the post by last date of submission of application form. Hence, **the candidate is not-eligible for the post.**

3. **Request of Sh. Anil Kumar S/o Sh. Rup Chand (Sl.No.):**

Sh. Anil Kumar vide e-mail dated 28th May, 2017 submitted that he has applied for the post of Library Attendant against notification No. 18 and claimed that his form was neither in the rejected list nor in the recommendation of Scrutiny Committee. In this regard, the Committee observed that the form of applicant has already been rejected on the ground of received after last date and the notification is already uploaded on website. Hence, **the candidate is not-eligible for the post.**
