Age: Preferably below 57 Years

Essential Qualifications and / or experience:

- i.) Master's Degree with at least 55% of the marks or its equivalent grade of 'B' in the UGC seven-point scale.
- ii.) At least 15 years' of experience as Assistant Professor in the AGP of Rs. 7000/- and above or with at least 8 years of service in the AGP of Rs. 8000/- and above including as Associate Professor along with experience in educational administration.

OR

Comparable experience in research establishment and / or other institutions of higher education.

OR


15 years of Administrative experience, of which 8 years shall be as Deputy Registrar or an equivalent post.

Desirable: Persons possessing Master's degree in Business Administration (Finance) / Commerce or possessing CA / ICWA qualification.

Note: 1. Candidates belonging to SC/ST/OBC/PwD categories are required to submit the Caste Category certificates as per Govt. of India format at the time of Interview, failing which their candidature may be rejected.

2. In-service candidates who have not forwarded their applications through proper channel are required to submit NOC at the time of interview failing which he/she shall not be interviewed.

3. Candidates who have submitted advance copy of application form must ensure that their original application form duly endorsed must reach the office atleast 10 days before the date of interview.
