Sub: Screening/ Scrutiny of forms for the post of **Senior Technical Assistant (Computer)** - Representation of candidates – Reg.


Ref: 1. Employment Notice No.17 dated 22.09.2016.
2. Screening Committee Recommendation Notification dated 08th February, 2017.

In response to Screening Committee Recommendation cited under reference, the University received following representations. The Screening/ Scrutiny Committee relooked into the representations and recommended the following:

- 1. Request of Sh. Sunil Kumar S/o Sh. Tarsem Kumar (Sl.No.46):**
Sh. Sunil Kumar vide his request dated 10.02.2017 has submitted copy of bonafide certificate in respect of his qualification. The Committee looked into his request and found that mode of Degree was Distance Education through Study Centre, which is not located in the State of the Degree issuing University. The candidate **is not eligible** for the post.
- 2. Request of Sh. Mohit Koul S/o Sh. Madan Ji Koul (Sl.No. 63):**
Sh. Mohit Koul vide his representation dated 14.02.2017 has submitted copy of documents for reconsideration of his candidature. The Committee looked into his request and found that he failed to produce documents in support of Experience as mentioned in the application form. The candidate **is not eligible** for the post.
- 3. Request of Sh. Tilak Raj S/o Sh. Tara Chand (Sl.No. 47):**
Sh. Tilak Raj vide his representation dated 17.02.2017 has submitted copy of documents for reconsideration of his candidature. The documents submitted do not reveal about the status of mode of degree obtained. In absence of supporting documents, the committee considers not to accept his request, the candidate **is not eligible** for the post.
- 4. Request of Sh. Ankush Sambyal S/o Sh. Prem Chand (Sl.No. 08):**
Sh. Ankush Sambyal vide his representations dated 21.02.2017 and 16.03.2017 has submitted documents in support of his candidature. On perusal the Committee found that the candidate lacks requisite Qualification and Experience The candidate **is not eligible** for the post.
- 5. Request of Sh. Neha Mahajan D/o Sh. Rakesh Mahajan (Sl.No.04):**
Ms. Neha Mahajan vide e-mail dated 20.02.2017 has submitted that she has already submitted copy of Experience certificate. The Committee has observed that the applicant has submitted copy of Experience certificate for the period from 01.09.14 to 19.05.15 which is short of requisite Experience. However, no evidence in support of 06 months experience, as claimed by the applicant is attached neither with the application form nor with the representation. **The candidate is not eligible for the post.**

Further, the candidature of below mentioned candidates is being rejected on account of their failure to submit the documents/ clarification as below:
