In response to Screening Committee Recommendation cited under reference, the University received following representations. The Screening/ Scrutiny Committee relooked into the representations and recommended the following:

- Request of Sh. Shiv Sachin Atri S/o Sh. Ram Dass Atri (Sl.No.29):**  
Sh. Shiv Sachin Atri vide request dated 13.02.2017 submitted the copy of Registration certificate as Pharmacist. The Committee considered the request and found that the candidate is not registered under Pharmacy Act, 1948. Hence **the candidate is not eligible for the post.**
- Request of Sh. Amit Plathia S/o Sh. Romesh Chander (Sl.No.53):**  
Sh. Amit Plathia vide request dated 13.02.2017 submitted the copy of Diploma. The Committee considered the request and found that the diploma is submitted instead of Registration certificate. Hence **the Candidate is not eligible for the post.**
- Request of Sh. Deep Singh S/o Sh. Surinder Singh (Sl.No.32):**  
Sh. Deep Singh vide request dated 13.02.2017 submitted the copy of Registration certificate as Pharmacist. The Committee considered the request and found that the candidate is not registered under Pharmacy Act, 1948. Hence **the candidate is not eligible for the post.**
- Request of Ms. Sandeep Kaur D/o Sh. Bakshish Singh (Sl.No.52):**  
Ms. Sandeep Kaur vide request dated 09.02.2017 submitted the copy of Registration certificate. The Committee considered the request and found that the registration expired in 2015. Hence **the candidate is not eligible for the post.**
- Request of Sh. Rohit Shan S/o Sh. Hukam Singh Shan (Sl.No.34):**  
Sh. Rohit Shan vide request dated 14.02.2017 submitted for reconsidering his candidature. The Committee found that the Applicant is not registered as Pharmacist under Pharmacy Act, 1948. Hence **the candidate is not eligible for the post.**
- Request of Sh. Parvaze Paul S/o Sh. B.M. Paul (Sl.No.09):**  
Sh. Parvaze Paul vide request dated 17.02.2017 submitted the copy of Registration certificate as Pharmacist. The Committee considered the request and found that the candidate is not registered under Pharmacy Act, 1948. Hence **the candidate is not eligible for the post.**
