- b. (i) At least 15 years of experience as Assistant Professor in the AGP of Rs. 7000/ and above or with at least 8 years of service in the AGP of Rs. 8000/- and above including as Associate Professor along with experience in educational administration.

OR

- (ii) Comparable experience in research establishment and /or other institutions of higher education. OR
- (iii) 15 years of Administrative experience, of which 8 years shall be as Deputy Registrar or an equivalent post.

Note: 1. Candidates belonging to SC/ST/OBC/PwD categories are required to submit the Caste/ Category certificates as per Gol format at the time of Interview, failing which their candidature may be rejected.

2. In-service candidate who have not forwarded their applications through proper channel are required to submit NOC at the time of interview.
