#### 11. NON-TEACHING RECRUITMENT:

The University conducted 2 tier tests for 21 non- teaching recruitment posts to fill up 30 vacancies. Written tests for these posts were conducted on 23.12.2017, 24.12.2017 and 07.01.2018 whereas Skills Tests for these posts were conducted from 12.07.2018 to 03.08.2018. Interview for Group A posts were held 29<sup>th</sup> - 30<sup>th</sup> August 2018. External experts and evaluators from reputed Central & State Universities and Govt. organizations have conducted the entire selection process. The entire selection process is available on the University website. After approval of Executive Council, vide resolution no. 5, 6, 7 and 8, the University has appointed 03 Group A Officers and 21 Group B and C employees. The Central University of Jammu advertised various Non-teaching posts vide Employment Notification No. 22 and 23 which includes the statutory posts of Controller of Examinations and Librarian.

In the august presence of all the dignitaries, two Memorandum of Understanding (MoU) were signed. One was between Central University of Jammu and Indian Space Research Organization (ISRO) to establish 'Satish Dhawan Centre for Space Science' and Second one was between Central University of Jammu and Central Scientific Instrumental Organization (CSIR-CSIO), Chandigarh.

In this regard Team of DRDO officials visited the University on Jan 15-16, 2019 wherein it was resolved to establish two verticals namely Computational Systems Security and Sensors. High performance computing facility in the University with 20-25 GPU Grade Server along with high speed networking infrastructure would be established to enable the research work under this vertical. DRDO will support budget for Consultancy, Logistic support, SRF, JRF, Training, Workshops, Conferences, Collaboration with other Academic Institutes etc. Five acres of land was identified for setting up the buildings and supporting infrastructure of the DRDO.
- 50. An MoU was signed between Indian Council of World Affairs, New Delhi and Central University of Jammu on 09 Feb 2019 to facilitate seamless movement and exchange of students, scholars and the faculty for an informed and rational view and interpretations of world affairs.

### **IMPORTANT VISITS**

- 51. On 7<sup>th</sup> August, 2018, Regional Director, NSS, New Delhi, visited Central University of Jammu regarding establishment of Empanelled Training Institutes for National Service Scheme (NSS) Programme Officers of Jammu & Kashmir State.
- 52. On 06<sup>th</sup> August, 2018, first meeting of the Subject Specific Expert Committee for drafting Learning Outcome based Curriculum Framework (LOCF) for Under-Graduate and Post-Graduate level on Management was conducted in the Vice Chancellor Secretariat, Central University of Jammu. Prof. Ashok Aima, Vice Chancellor, Central University of Jammu (Chairperson of the above said committee) and Prof. B. Raja Shekhar, School of Management Studies, University of Hyderabad (Member of the Committee) besides six internal committee members constituted by Vice Chancellor, CUJ, attended the meeting.



- 53. First meeting of the Academic Council of National Resource Centre, Human Resource Management, was held on 10<sup>th</sup> August, 2018, at IIC, New Delhi. The mandate of the NRC is to provide online orientation/refresher courses to higher education faculty through MOOCs platforms like SWAYAM. The meeting was attended by Prof. Ashok Aima, Vice Chancellor, Central University of Jammu; Prof. TV Rao, Prof. M.I. Haque, Prof. Naval Kishore, Shri Subash Jagota, Shri. Nalin Srivastava, Shri Kamal Singh, Prof. L.K. Verma (Coordinator NRC), Dr. Jaya Bhasin & Dr. Shahid Mushtaq (Course Coordinators).
- 54. On 17<sup>th</sup> August, 2018, Prof. Ashok Aima, Vice Chancellor, Central University of Jammu, attended the 81<sup>st</sup> meeting of the Executive Committee of National Assessment and Accreditation Council (NAAC), held at Board Room, NAAC, Bengaluru.
- 55. The CUJ under the MHRD flagship programme UBA conducted Gram Sabha of four villages with the cooperation of the Samba District Administration on the occasion of 72<sup>nd</sup> Independence day at Jhang panchayat which has been adopted by the University. Prof. Ashok Aima, Vice Chancellor, Central University of Jammu, was the chief guest for the occasion. It is pertinent to mentioned here that the CUJ has been recently selected through challenge mode and become the Participating Institute under Unnat Bharat Abhiyan by signing MoU with IIT-Delhi, the National Coordinating Institute.
- 56. From 22-27 October School of Business Studies, Central University of Jammu became the first University in Northern India to conduct a collaborative Project on "Leadership through Sports Program for Jammu and Kashmir" with Ball State University, USA. In this program Five American sports mentors/coaches (three female and two male) from USA shared best practices on how to build sports and leadership programs in underserved communities. Upon completion of the week-long workshop, the Ball State University, Muncie, Indiana is overseeing a six-month virtual mentoring program between the American sports mentors/coaches and the participants. The entire funding would be borne by the Ball State University, Indiana, USA under US Mission India Public Diplomacy Grants Program. In this program 20 sports persons from across the three regions, Ladakh, Kashmir valley and Jammu participated in the event.
- 57. From 10<sup>th</sup> September, 2018 to 05<sup>th</sup> October, 2018, Prof. Sei-Chiro Ueki, Tokai University Japan, visited Department of Mathematics, Central University of Jammu. The main purpose of this visit was to strengthen the research ties between two universities. Prof. Ueki, has already established a collaborative research link with Dr. Ajay K. Sharma, Head, Department of Mathematics, Central University of Jammu and they have jointly published 05 research papers in lading international journals.



- 58. On 15<sup>th</sup> November, 2018, Amb. G. Parthasarathy, Hon'ble Chancellor, Central Univrsity of Jammu visited the CUJ campus and interacted with the Vice Chancellor, Registrar, faculty and students of varius departments.
- 59. On 12<sup>th</sup> November, 2018, Prof. Ashok Aima, Vice Chancellor, Central University of Jammu, met Shri E.V. Eapen, IAS, Secretary, DARPG at New Delhi and gave presentation regarding establishment of "Atal Centre for Good Governance & Policy Studies" at Central University of Jammu.
- 60. In pursuance of Central Information Commission order, RTI Cell of the Central University of Jammu organized awareness programme on RTI for the faculty members and administrative officers of the Central University of Jammu on 5<sup>th</sup> December, 2018.
- 61. Prof. Ashok Aima, Vice Chancellor, Central University of Jammu met with the Hon'ble Governor, J&K State, Shri Satya Pal Malik at Raj Bhavan, Jammu on 02<sup>nd</sup> January, 2019, and briefed him about the functioning of the University. Governor emphasized the importance of continuining hard work by the faculty and students for achieving the highest standards in teaching, research and extra-curricular activities.
- 62. On 14<sup>th</sup> January, 2019, Prof. Ashok Aima, Vice Chancellor, Central University of Jammu, attended the Experts Committee meeting to reassess the de-novo aspect of the proposal of Institute of Rural Management, Anand (Gujarat) for Deemed to be University Status held at UGC Office, New Delhi.
- 63. In order to promote sports excellence and to formulate a long term sports policy, the Central University Jammu conducted its first Sports Advisory Council meeting at its main campus. The meeting was chaired by Hon'ble Vice Chancellor, CUJ, Prof.Ashok Aima who briefed about various achievements and initiatives taken by Central University of Jammu. A council constituting of top sports achievers and experts of International Standing from the state comprised Shri Ranjeet Kalra ,Co-chairman of the Council & Advisor for Sports, Govt. of Lakshdweep; Shri Haji Abdul Qayoom ,Chief Sports Officer, J&K Sports Council; Shri Ashok Kumar, Director Sports, Shrine Board, Katra, Shri S.P.Singh, Senior Officer J&K State Sports Council and other senior sports members of J&K State.
- 64. On 29<sup>th</sup> January, 2019, live video conferencing of the unique interaction programme "Pariksha Pe Charcha 2.0" was held in the Brig. Rajinder Singh Auditorium, Central University of Jammu in which Hon'ble Prime Minister, Shri Narendra Modi Ji, discussed regarding exams, life and more with students, teachers and parents across the nation. Prof. Ashok Aima, Vice Chancellor, Central University of Jammu along with Registrar, Deans of



Schools, Heads of Departments and large number of students and scholars attended the said programme.

### To consider biannual admission in Ph.D. courses offered by the University

The University offers Ph.D. courses in 19 departments and 02 Centres. Admissions to Ph.D. courses is effected through common entrance test i.e. Central Universities Common Entrance Test (CUCET) which takes place in the month of April - May every year. After declaration of result, candidates are admitted in the month of August – September every year.

Whereas, UGC NET exams are conducted twice every year by National Testing Agency (NTA) in the month of June and December. JRF / NET qualified candidates are usually absorbed by other Universities before Ph.D. admissions take place in Central University of Jammu.

In view of the above, it is proposed that candidates may be admitted to Ph.D. courses twice in an academic year i.e. first time through CUCET in the month of July – August and thereafter in the month of January – February from amongst JRF/NET qualified candidates who have qualified NET/JRF in the preceding 1 year.



# To consider establishment of Community Radio Station in the University

The University has applied for Community Radio Station (CRS) vide its letter no. CUJ/Reg/Admn/Comm.Radio/1071 dated 12.06.2014. The Ministry of Information and Broadcasting vide F. No. 104/101/2016-CRS dated 02.01.2017 issued letter of intent for setting up of CRS. Accordingly, the University applied for frequency allocation vide letter no. CUJ/Reg/Admn/Comm.Radio/2015-16/56 dated 10.02.2017.

The Department of Telecommunication, Ministry of Communications and Information Technology, Government of India vide letter no. L-14024/29/2017-WF/562 dated 20.12.2017 communicated its decision to grant Wireless Telegraph Station with frequency 91.2 MHz.

Department of Mass Communication and New Media may be authorised to establish CRS in the Campus.

# To consider change of nomenclature of Department of English and Comparative Literature

The Department of English and Comparative Literature started its functioning w.e.f. Academic Session 2012-13 with its thrust area as core English Literature. Keeping its thrust area in view, Head, Department of English and Comparative Literature and Dean, School of Languages have recommended to change the nomenclature of the Department to Department of English instead of Department of English and Comparative Literature.

The matter is placed before Academic Council for consideration and recommendation to Executive Council.



## To co-opt 10 members in the Academic Council, not in the service of University

The University constituted 3<sup>rd</sup> Academic Council on 26.02.2019 pursuant to Statute 13 (amended). As per clause 13(1)(m) the constitution of Academic Council includes:

"10 members not in the service of the University, co-opted by Academic Council for their special knowledge in educational progress, development and industry linkage". Such members shall hold office for a term of 3 years".

The matter is placed before Academic Council for co-option of 10 members in Academic Council having special knowledge in educational progress, development and industry linkage.



To consider revised new dynamic fee structure for all courses offered by the University w.e.f. academic year 2019-20

The University revised its fee structure in the year 2016-17. UGC/MHRD has intimated that newly established Central Universities should be self sufficient and self dependent in terms of financial sustenance. It is, therefore, necessary that fee structure of all courses should be revised at appropriate intervals. Academic Council in its 10<sup>th</sup> meeting held on 24<sup>th</sup> August, 2018 has approved revised Fee structure for all courses w.e.f. fresh admission batch 2019-20. However, the approved fee structure requires rationalization in terms of Fee charged by the University as one time Fees, Annual fees, Departmental charges etc.

Revised new dynamic Fee Structure recommended by the Fee Structure Committee is placed at **Annexure – I**.

The matter is placed before Academic Council for consideration and recommendation to the Executive Council.



# To consider One year Certificate courses offered by Centre for Comparative Religions and Civilizations

The University has established 02 Centres viz. Centre for Molecular Biology and Centre for Comparative Religions and Civilizations (CCRC). Academic Council in its 9<sup>th</sup> meeting held on 20.01.2018 vide resolution no. 49 has approved Ph.D. in CCRC subject to availability of eligible Supervisors and infrastructural facilities.

Board of Studies in its meeting held on 29.04.2018 has proposed the following courses and the same have been recommended by the Dean, School of Humanities and Social Sciences:

- i. One year Certificate course in Shaivism.
- ii. One year Certificate course in Indian Mystical Thought.

The agenda is placed before Academic Council for consideration and recommendation to the Executive Council.



To confirm action taken by the Vice Chancellor in having authorized adoption of the syllabi and courses of study of Master's Degree Programmes, in anticipation of approval of the Academic Council

As per Ordinance No. 3, Clause 13 of the University, the detailed course outline shall be prepared by the Board of Studies and shall be approved by the Academic Council. The Vice Chancellor in anticipation of the approval of the Academic Council accepted the recommendations of the Board of Studies / Dean of the concerned schools, and authorized adoption of the syllabi and courses of study, in order to facilitate teaching of the courses in Master's Degree Programmes of various Departments as per details given below:

### To consider course strength of PG and integrated Courses

The University is offering various PG and integrated Courses with intake capacity of approx. 40 students per course. UGC and MHRD have advised the University to be self sustaining and have linked the release of funds with intake capacity.

In view of above, it is proposed that intake capacity in each course be increased upto 50 students per course w.e.f. Academic session 2019-20 which includes reservation for PWD, EWS, SC, ST and OBC as per national reservation policy of India. Super numerary seats in each course has already been approved by the Academic Council in its 10<sup>th</sup> meeting held on 24.08.2018 vide resolution no. 63. Further, it is proposed that 01 seat in each course be considered as super numerary seat for Single Girl Child as per national policy.

The matter is placed before the Academic Council for consideration and approval.



## To consider recognition of Courses offered by Department of Education with NCTE

The University established Department of Educational Studies in the year 2012-13 with M.Ed. course. During the Academic session 2018-19, the Academic Council in its 10<sup>th</sup> meeting held on 24.08.2018 vide item no. 36 has approved B.A.— B.Ed. course under Pandit Madan Mohan Malviya National Mission on Teachers and Teaching (PMMMNMTT). These two teachers—training programs should be approved by National Council for Teachers Education (NCTE) in terms of chapter 4 of NCTE Act 1993.

Department of Educational Studies may be authorised to seek recognition of these courses from NCTE.



# To consider Ordinance with Exit option in Integrated Courses offered by the University

The University started four 05 year integrated courses viz. integrated M.Sc. in Physics, Chemistry, Botany and Zoology w.e.f. Academic Session 2016-17. For students, who desire to complete graduation (B.Sc. Hons.) after 3 years without further pursuing PG course, the Academic Council in its 10<sup>th</sup> meeting vide item no. 25 has approved the Ordinance for Exit option to such students.

The University vide notification no. 8 of 2018 has constituted a committee to frame draft Ordinance for Exit option and lateral entry for such integrated courses. The committee is in the process of finalising the draft Ordinance and the same will be placed on table before the Academic Council.



# To consider recommendations of Committee constituted for Assessment of some Departments and Centres

The Vice chancellor has constituted an Assessment Committee comprising 05 Professors of the University to take a detailed stock of functioning and output of some Departments and Centres keeping in view the overall University Academic and Administrative interests. These Departments / Centres are:

- 1. Department of Nano Sciences and Materials
- 2. Department of Mass Communication and New media
- 3. Department of Public Policy and Public Administration
- 4. Department of National Security Studies
- 5. Centre for Comparative Religions and Civilizations
- 6. Centre for Molecular Biology

Admission status of these Departments since inception is placed at **Annexure – VI**.

The Committee is in the process of finalising its report which will be placed on table before Academic Council.



# To consider change of nomenclature of Department of Nano Sciences and Materials

The Department of Nano Sciences and Materials was established in the year 2016-17. The Course offered by the Department is M.Sc. in Materials Science and Technology. Board of Studies of the Department of Nano Sciences and Technology in its meeting held on 02.06.2018 has recommended to change the nomenclature of Department of Nano Sciences and Materials to Department of Materials Science keeping in view the study of different aspects of materials and course structure.

Minutes of Meeting of Board of Studies and recommendation of Dean, School of Basic and Applied Sciences is placed at **Annexure – VII**.

The matter is placed before Academic Council for consideration and recommendation to Executive Council.



## To consider admission to Ph.D. Courses in various languages

Central University of Jammu has 19 Departments and 02 Centres which offers Ph.D. Programs in respective fields. At present, these Ph.D. programs are offered in English language only subject to the requirement of particular field. University has 02 Departments of languages i.e. Department of English and Department of Hindi.

It is therefore proposed that these Ph.D. courses may be offered only in these two languages till new Departments of other languages are established in the University.

The matter is placed before Academic Council for consideration and approval.



## To consider format of One year PG Diploma in Yoga

Academic Council in its 9<sup>th</sup> meeting held on 20.01.2018 vide resolution no. 54(1) has approved the introduction of one year PG Diploma in Yoga. 30 students were enrolled in this course and will be passed out after appearing in 2<sup>nd</sup> semester.

Format of PG Diploma to be awarded to passed out candidates is placed at **Annexure – VIII**.

The matter is placed before Academic Council for consideration and approval.



### To consider duties and functions of Dean, Research Studies

The Vice Chancellor has, in exercise of powers vested by section 11 clause 3 of Central Universities Act 2009 has appointed one Professor as Dean, Research Studies to make provision for research and for advancement and dissemination of knowledge as per section 6(1)(i) of Central Universities Act 2009.

Dean, Research Studies has proposed duties and functions, which are as follows:

- a) Facilitate and promote quality research.
- b) Coordinate, supervise and recommend to the Vice Chancellor for the approval of the admission of students to Ph.D. and other research programmes.
- c) Recommend to Vice-Chancellor in consultation with Deans of the faculties modification, amendment in the statutes governing the admission of students to Ph.D. and other research programmes for placement before relevant statutory bodies (if necessary).
- d) Coordinate and facilitate for timely Board of Studies meeting.
- e) Coordinate and facilitate submission of research project proposals to various funding agencies by Principal Investigators and would also be accountable and responsible for their internal monitoring. For this purpose a Projects and Planning Cell would be created which would function under Dean Research. He will be accountable and responsible for timely disposal of all matters, including financial issues related to research projects, fellowships and scholarships.
- f) Provide necessary guidance and encourage teachers/researchers to write research project proposals and suggest incentives/other initiatives to the Vice-Chancellor for the purpose.
- g) Liaise with relevant international, national / regional agencies / organizations / group/ individuals for financial support and promotion of quality research in the University.
- h) Supervise and promote the quality of research journals published by the University.
- i) Recommend as Chairperson of a committee (to be formed by the Vice-Chancellor) for allocation of plan and non-plan research grants received by the University to various departments/research centres based on their need and contribution.
- j) Identify key areas of research in consultation with Deans and HOD's and ensure promotion to achieve national eminence in such areas.
- k) Prepare annual research report and identify the initiatives for promoting/maintaining quality of the research.
- I) Keep track of research / visiting schemes advertised by various funding agencies, national and foreign and shall sensitize the University and all concerned.
- m) Responsible for effective utilization of grants from Central/State agencies for research related infrastructure.
- n) Responsible and accountable for purchase/procurement of scientific equipment in consultation with a duly constituted Purchase/Technical Committee to be nominated by the Vice-Chancellor.
- o) Responsible to receive/disburse and accounting of financial support offered by various funding agencies or projects related to research and its infrastructure development.
- p) Supervise and carryout and other work related to the research to be assigned by the Vice-Chancellor.
