Last date for receiving applications: within 21 days from the date of publication.

The decision of CU Jammu regarding empanelment of Vendors / Distributors/ Library Suppliers shall be final.

Instructions for Applicants:

- 1. Interested Vendors/Distributors/Library Suppliers should submit applications in sealed envelopes super scribing Application for Empanelment for Supply of Books to Central Library, Central University of Jammu, Main Campus Bagla, Rahya-Suchani, Samba-181143.
- 2. The application should be signed by the authorized person and his full name and designation should be indicated below his signature along with the official seal of the firm.
- 3. Incomplete and conditional applications shall be rejected.
- 4. At any given point of time, if any of the documents furnished by the Vendors/Suppliers is found to be false, it would be deemed to be breach of terms of contract making the concerned firm liable for legal action besides termination of empanelment.
- 5. Canvassing in any form will lead to disqualification of the firm.
- 6. Any application received after due date shall be rejected.
- 7. The Vendor(s)/Distributors(s)/Library Supplier(s) short-listed for empanelment are required to agree to supply as per the University's '<u>Terms & Conditions'</u>.

Terms and Conditions

1 Membership Certificate & PAN Card: A photocopy of a <u>membership certificate of federation</u> <u>publishers or booksellers association</u> for the current financial year and photocopy of the <u>PAN card</u> must be attached with the bill(s).

- 2 Intimation of ability/inability to supply: The Library must be intimated within <u>7 (seven)</u> working days from the date of the issue of supply order, his ability/inability to supply the items (book <u>titles</u>), so that in case of latter CUJ may procure the material from an alternative source.
- 3 <u>Delivery Schedule:</u> Delivery should be:
 a. <u>Books Selected during exhibition</u>: Books along with bills are to be delivered within a week's time from the date of order.
 - b. <u>Books on approval</u>: within <u>One (01) month for Indian Publications</u> and <u>8-10 weeks for Foreign Publications</u> from the date of Purchase Order.

All books must be supplied within the mentioned period, failing which, the order will automatically stand cancelled and no supply will be accepted against the orders after the expiry of the period.

4 Books are required to be **delivered to <u>the University Librarian</u>**, <u>Central University of</u> Jammu, <u>Main Campus Bagla</u>, <u>Rahya-Suchani</u>, <u>Samba-181143</u> for <u>all books suppliers</u>.

5 Discount: At least _____ % (______ per cent) discount must be provided as offered by the supplier.

6 Short discounted books: For <u>short discounted books – supplier will have to provide</u> price proof <u>documents in support of the prices charged</u>. This will help in identifying the less discounted books.

7 Any **title** supplied **not in accordance** with our order will not be accepted in any case.

8 In the event of non-supply of any title the supplier will have to furnish cogent reasons for the same; such as for the following:

- a. <u>books out-of-print</u> confirmation letter <u>from the Publisher</u> in support **OR**
- b. <u>books out-of-stock from the Distributor</u> **OR**
- c. <u>Print-on-demand</u>: time required for supply with copy of response from the publisher/distributor as proof **OR**
- d. <u>Back-order books</u>: time required for supply with copy of response from the publisher/distributor as proof \mathbf{OR}
- e. <u>Market restriction proof</u>
- 9 Only **low priced latest Indian editions** will be accepted wherever published. In case of increased price of new editions only mentioned editions are to be supplied.
- 10 The supplier will be required to provide "**Publisher's Price Proof**" along with the supply of books in support of the <u>price is not printed / increased price/ price higher than the printed price</u> of the book.
- 11 **RBI** (**Reserve Bank of India**) **rates** will be applicable **for foreign books** <u>prevailing at the time of signing of this order</u> & will remain unchanged.

- 12 **Bills** shall be submitted in triplicate in the name of the <u>University Librarian, Central University of</u> <u>Jammu, Main Campus Bagla, Rahya-Suchani, Samba-181143, India</u> (J&K). The original should be pre-receipted on revenue stamp.
- 13 The books shall be **properly packed and delivered** at supplier's expenses & risk. Damaged books will not be accepted.
- 14 No **claim of insurance** is admissible. Supply shall be affected either at transporter's risk or at supplier's risk.
- 15 Supplier must mention **Purchase order number** and **date** at the top of each individual bill.
- 16 **Payments** will be made within <u>60 days</u> of the receipt of books in good condition at site i.e. at CUJ campus and after submission of all necessary documents required for payment.
- 17 Central University of Jammu(CUJ) reserves the right to rectify the mistakes arising out of typographical / clerical errors / arithmetical inaccuracies, notwithstanding payments made, if any.
- 18 In case of any dispute arising out of interpretation of any clause, the decision by CUJ shall be final, conclusive and binding on the supplier. All legal disputes are subject to the Jammu courts jurisdiction only.
- 19 All freight charges/forwarding charges will be borne by the firm supplying the books.
