Agenda Item 10.1: The Course Matrix for Post graduate Diploma /Degree Course: Approved.

The Course Matrix for Post graduate Diploma /Degree Course was approved after long and seriou deliberations on the relevance of the Core and Open Elective courses to the integrity of the specific discipline at the post-graduate level. The subject experts made the following suggestions:

1. Research Methodology (Core) should be offered in Semester III (incorporated in the Matrix) (Annexure I A)

2. The number of Open Electives courses should be increased in the subsequent years in a phased manner.

3. The response of the students to these changes, and the achievement of the Course Learning Outcomes (CLOs) should be noted for making suitable changes so that the syllabus moves towards realisation of the vision of NEP 2020.

Agenda Item 10.2: Programme Learning Outcomes (PLOS) for Post graduate Diploma/Degree course Approved as it is. (Annexure I B)

## Agenda Item 10.3: Core Courses: Approved with some suggested changes.

After thorough discussion on the proposed courses, the Experts made the following recommendations:

- Uniformity of structure in all the courses and as far as possible all genres should be reflected in the course
- The first unit in all courses should be introductory
- The number of primary texts should be increased
- Texts that cannot be accommodated in the course should be added to the Recommended Readings.
- Change of name of the proposed Course "Post-colonial Indian Writings in English" to "Post-Independence Indian Writings in English."

These suggestions have been incorporated in the Core as well as Open Elective courses. (Annexure II)
