**Essential Qualifications and/or experience:**

- i. Bachelor's degree in Engineering (Civil) from a recognized University/ Institute or equivalent.
- ii. Eight years of experience in relevant field as Assistant Engineer from CPWD/ State Government PWD services or similar organized services/ Semi Government/ PSU/ Statutory or Autonomous organization/ University System/ reputed private organizations.

Relaxation of two years in experience will be given to those possessing Post-Graduate qualification in Construction Management/ Structural Engineering or equivalent fields.

**Desirable:**

- i. Experience in construction projects of multistory buildings and have experience in planning/ estimation/ tendering as per the CPWD/ PWD norms. Good knowledge of CPWD manuals, preparation/ checking of estimates, drawings, structural details, bill of quantities, substitute/ deviation items statements and other associated issues related with building and constructions.
- ii. Knowledge of Computer Aided Design (CAD) and latest Management Technology/ other relevant software.
