
This is with reference to representation received from the Ms. Twinkle Suri wherein she has requested for considering his candidature for the post of Controller of Examination.



The documents submitted by him contained opinion of State Law Secretary towards his eligibility. The opinion provided conveyed a different interpretation in the light of advertisement.

Therefore, legal opinion was sought from the Standing Legal Counsel of the University, who stated that Sh. Jai Kumar Sharma lacks the experience as required under the Advertisement.
