In response to Screening Committee Recommendation cited at 2, the University received following representations, which are considered/ disposed of as below:

### 1. Request of Mohd. Aslam Beig S/o Ab. Majid Beig (Sl.No.08):

Mohd. Aslam Beig vide e-mail dated 08.08.2017 represented to reconsider his candidature. The committee looked into his request and found that the candidate is short of requisite experience. Hence, the candidate is not eligible for the post.

# 2. Request of Mir Javed Ahmad Jeelani S/o Mir Abdul Ahad (Sl.No.30):

Mohd. Aslam Beig vide e-mail dated 08.08.2017 represented to reconsider his candidature. The committee looked into his request and found that the candidate is short of requisite experience. Hence, the candidate is not eligible for the post.
