In response to Screening Committee Recommendation cited at 2, the University received following representations, which are considered / disposed off as below:

- Request of Dr. (Mrs.) Vinay Singh Kashyap D/o. Sh. Gopal Krishna Mehra (Sl. No.02):**  
Dr. (Mrs.) Vinay Singh Kashyap vide her representation dated 06.06.2017 submitted documents / reference of her counting Experience for the post. The Committee looked into the request and considered not to count the contractual / adhoc experience for the post and thus the candidate is short of requisite Experience. Hence, **the candidate is not eligible for the post.**
- Request of Sh. Suneel Kumar Bhat S/o Sh. Shiv Jee Bhat (Sl. No.03):**  
Sh. Suneel Kumar Bhat vide his representation dated 12.06.2017 has requested to consider his candidature by allowing him to again submit the API Score as per IV<sup>th</sup> Amendment, 2016. However, Sh. Suneel Kumar Bhat was already given an opportunity to submit the documentary proof in support of API score claimed vide letter No. CUJ/Admin./1-12/3(Lib.)/2016/59 dated 20<sup>th</sup> January, 2017 and he has already submitted his response. The committee looked into his documents and found that he is short of required API score. Hence, **the candidate is not eligible for the post.**
- Request of Sh. Romesh Chander S/o. Sh. Dev Raj (Sl.No.04):**  
Sh. Romesh Chander vide his representation dated 01.06.2017 and 06.06.2017 claimed that he possess the requisite API score to be eligible for the post of Deputy Librarian and enclosed year wise summary of API. The Committee looked into the request and found that Sh. Romesh Chander, possesses API score less than 300, as required for direct recruitment (Cat II & III). Hence, **the candidate is not eligible for the post.**
- Request of Ms. Prerna D/o Sh. Avinash Chander (Sl.No.10):**  
Ms. Prerna vide her representation dated 05.06.2017 claiming that she possess the Experience required for the post. The committee looked into her request and considered not to count the contractual / adhoc experience for the post and thus the candidate is short of requisite Experience. Hence, **the candidate is not eligible for the post.**
