



#### Resolution 14.2:-

The Centre for Translation and Archiving approved to be set up under School of Languages proposes to start a PG Diploma in Translation Studies. The Dean, Prof. Vandana Sharma highlighted the learning outcomes of the diploma course which would be to follow the spirit of NEP 2020 and initiate translation not only into English but across the Indian languages. Therefore, the course is proposed to be started through distance learning mode with significant thrust on workshop method wherein the registered candidate will be required to attend



mandatory some sessions in person too. To this, the Expert, Prof. Malashri Lal added that keeping in view the challenges of accessibility which is PAN India for such courses, the Course may be started in distance learning mode with significant thrust on languages in the region and UT of Jammu and Kashmir. There should be focus on lost languages and a component of Feld work and Translation sample and essay may be added in the contents.




