- 4. The Vice Chancellor warmly welcomed Prof, Udai Partap Singh, Prof. Vineeta Singh, and Prof. Sushil Kumar Gupta, worthy members of the newly constituted 3rd Executive Council who attended the meeting for the first time at Central University of Jammu. The Vice Chancellor also welcomed Prof. Javed Mussarat and Prof. Manoj Dhar, who attended the meeting as Special Invitees. The Vice Chancellor expressed sincere gratitude towards members for attending the 15th meeting of the Executive Council.
- 5. The Vice Chancellor expressed sincere thanks to the outgoing members of the Executive Council for their tremendous support and guidance in framing the best policies for the betterment of the university and their tireless efforts in establishing the national character of the university.

- The Vice Chancellor also expressed his sincere gratitude to Dr. Radhakrishnan for the establishment of "Satish Dhawan Centre for Space Science" at Central University of Jammu.
- 6. The Vice Chancellor apprised the members about the paperless and cashless initiatives adopted by the university to minimise the use of paper and other resources which helps in developing environment friendly practices. Prof. Udai Partap Singh suggested that the university may place the hard copies of the Agenda and Annexure during the meeting for outside university members due to internet problems in the Union territory.
- 7. The worthy members were apprised about the logo of the university and its description by the Vice Chancellor.
- 8. The Vice Chancellor informed the members that the university had dehired the rented building i.e. Temporary Academic Block (TAB) situated at Sainik Colony, Jammu, which was earlier utilized for running various programs till June, 2018. Now, the university is running only Yoga Centre, Competitive Coaching Classes for civil services and Community College in a limited hired portion of the building.
- 9. The Vice Chancellor also informed the members that the university has discontinued free university hired private bus service for the students. Now, the university has hired buses from the Jammu and Kashmir State Road Transport Corporation (JKSRTC), Jammu, on a monthly fare of Rs.1400/- per student which is paid by the student who wish to avail the bus services. The Vice Chancellor further informed that some students have made their own arrangement by hiring mini buses as per their requirements and convenience. He also informed that the university has been providing free bus shuttle service from Rahya Morh (National Highway) to University Campus and back for the convenience of the students until it is made all weather road.
- 10.Prof. Udai Partap Singh suggested that before starting the Agenda Items, the deliberations, decisions and action taken on the agenda items of the last meeting of the Executive Council shall be discussed first so that the new members shall be made aware of the proceedings of the last meeting of the Executive Council. Prof. Javed Musarrat also suggested that the Agenda Item No.1 may be changed as Overview of the University.
- 11. The Vice Chancellor informed that the university had conducted written tests of various Non-Teaching positions of Group B & C posts, advertised vide Employment Notification No.22 dated 09.01.2019 and skill/ Applied tests will be held from 24th December, 2019 onwards.
- 12. The Vice Chancellor apprised the members that the Central University of Jammu has got B++ ranking with score of 2.88 by the National Assessment & Accreditation Council (NAAC), Bangalore, in the first

cycle. He informed that the Central University of Jammu is holding the top position among the other 07 New Central Universities which had undergone for NAAC accreditation.

- 13. Prof. Udai Partap Singh was concerned about holding the meeting of the Executive Council of the university after a gap of more than one year. The Vice Chancellor informed that the MHRD has sent the approval of the Visitor's Nominee on the Executive Council few months back which caused some delay in holding the meeting. Prof. Udai Partap Singh suggested that the meetings of the Executive Council may be held at least twice in a year. The Vice Chancellor assured the members that the Executive Council meeting shall be held at least twice in a year in future.
- 14. Prof. Udai Partap Singh enquired about the holding of Convocation. The Vice Chancellor informed that the first Convocation of the university was held on 18th March, 2018 and the university is planning to hold the 2nd Convocation in the first quarter of the year 2020. Prof. Singh suggested that the university shall hold Convocation every year. The Vice Chancellor assured the members that Convocation will be held every year or once in two years depending upon the number of graduating students/scholars
- 15. The Vice Chancellor suggested that he may be authorised to take decision on the matters which needs urgent action either by circulation among the worthy members through email or the action taken shall be put in the next Executive Council for their approval.
- 16. Prof. Udai Partap Singh enquired about the progression of students in the university. Prof. Jaya Bhasin, Chairperson, UBIC, Central University of Jammu informed that some proposals have been received by University Business Incubation Centre besides Entrepreneurship Development program(s) have been organised for the benefit of students and faculty under DST-NIMAT project.

Further, Director, DIQA apprised the members that Annual Alumni Meet is a regular affair to map the student progression and are also involved in Placement and other academic activities.

Prof. Jaya Bhasin, Dean School of Business Studies observed that Board of Studies meeting referred in agenda item No 1 "MBA (Marketing and Supply Chain Management)" need to be read as "Marketing and Supply Chain Management".

Prof. Udai Partap Singh suggested that Alumni Meet should be held from time to time so that the university shall track the progress of the alumni and data can be generated for the records of the university. The Vice Chancellor reassured the members that Alumni Meet is held every year. He further assured the members that mechanism to create data bank

about the progression of the alumni is already in place and will be further strengthened as suggested.

- 17. The Vice Chancellor presented the details of various research projects obtained by the faculty of the university. He apprised the members that more than 46 research projects have been funded from different external organisations amounting to nearly Rs 20 crores besides funding from DRDO & ISRO as well would more than Rs 80 crores. The worthy members appreciated the efforts of the Vice Chancellor in attracting the best talented faculty from across the globe who have contributed tremendously in the development of the university.
- 18. Prof. Udai Partap Singh informed that a complaint has been received by all members of the Executive Council from a female student with serious allegations on the faculty member. The Vice Chancellor informed that various anonymous complaints were received earlier through email/by post by the university authorities. The university authorities were unable to contact the person as the complainant has not provided any contact details like telephone number, valid email id, and correspondence address for presenting the facts to the authorities to address the grievances/complaints received from the aggrieved students/scholars. Prof. Udai Partap Singh suggested that a four member committee shall be constituted to look into this complaint in a discreet manner to dispose off the matter in a expeditious manner. The composition: the committee be as under:
 - a) Prof. Vineeta Singh EC Member b) Prof. Sushil Kumar Gupta - EC Member c) Prof. Jaya Bhasin - EC Member d) Prof. Govind Singh - EC Member
- 19. The Executive Council authorised the Vice Chancellor to take a decision on the complaint and the Executive Council shall be informed in the next meeting.
- 20. Prof. Udai Partap Singh informed that another complaint has been received through email by all members of the Executive Council regarding criteria adopted by the university for the selection of non-teaching positions. He suggested that a two member committee be constituted to look into this complaint. The Executive Council authorised the Vice Chancellor to take a decision on the complaints and the Executive Council shall be informed in the next meeting.
- 21. Keeping in view the academic and administrative interests of the University as well as UGC guidelines on engagement of contractual faculty, it was resolved to create a pool of Guest Faculty/Resource

Person(s)/Subject Expert(s) in order of merit by following procedure and the laid down criteria in this regard for each academic session/semester. The said need based engagement shall be made on the recommendations of concerned Head and Dean for a limited duration and on purely temporary basis to be duly approved by competent authority after issuing proper advertisement as per the projected requirement of respective courses instead of hiring Assistant Professors on contractual basis for full one academic session.
