Joint Secretary and Financial Advisor, MHRD vide email dated: 07.06.2016 conveyed comments on the agenda items which have been incorporated in the minutes.

At the outset, the Vice Chancellor extended a warm welcome to the members and expressed his sincere thanks to the members for sparing their valuable time to attend the 11th meeting of the Finance Committee.

The Vice Chancellor briefed the members about the various activities undertaken by the University through Power Point Presentation. He apprised the members about the Memorandum of Understanding (MOUs) signed by the Jammu with national and international Central University of organizations/Universities. He further added that the Central University of Jammu is going to start 08 new programmes in the ensuing academic session. The result of the CUCET - 2016 will be declared on 17th June, 2016. He further apprised about the academic and research achievements. The special focus was on outreach activities like the establishment of Community Development Cell, adoption of Villages and Schools, capacity Building Programme for Teachers and Administrators and Students-Oriented Support Programme. He laid emphasis on Infrastructure Development Progress under which Action Plan for construction of various Buildings Projects during XII Plan, Existing Academic Building, Hostels, Faculty Quarters, Guest House, etc., have been re-prioritized. He also informed that Central University of Jammu has a deep drilled Commissioned Tube Well and

the water is being used by the University to meet its own requirements besides supplying to construction companies on the campus on payment basis.

Thereafter the Agenda items were taken up for discussion.

The Committee noted the reprioritization of works as briefed by the Vice Chancellor. Also resolved that the Vice chancellor should take up the matter with UGC/MHRD for seeking the additional funds to make up the deficiency.

The Joint Secretary and Financial Advisor, MHRD vide email dated 07.06.2016 has suggested that the relevant details needs to be furnished in the prescribed format. However, it is pertinent to mention that the relevant details were placed before the Hon'ble members during the course of meeting.

Any other item:

Prof. Jai Prakash Sharma desired to know about the various Departments being run from the campus. The Vice Chancellor informed that presently the Department of Environmental Sciences and Department of Educational Studies are functioning from the Campus. He further added that in the next Academic Session 08 new Departments would be shifted on the Campus.

Sh. C.P. Ratnakaran desired to know about the filling up of the position of Finance Officer on regular basis in the University. The Vice Chancellor informed that the post of Finance Officer was advertised a number of times. However, in the absence of eligible candidates the post could not be filled. He further added that the post was re-advertised, and in response to this, interview was held on 29.03.2016. However, one of the candidates has filed a writ petition and the matter stands subjudice. The Vice Chancellor also informed that in these circumstances, as an interim arrangement, the Registrar has been authorized to perform the additional duties of the office of Finance Officer. It was suggested that conflict of interest may arise if Registrar also holds the charge of the post of Finance Officer, which needed to be rectified.

Prof. A.M. Pathan suggested that in view of the aforesaid position, the Vice Chancellor may consider giving additional charge to a Deputy Registrar and may also write a letter to CAG/AG Jammu/Srinagar for sparing the services of suitable officer of the rank of the Deputy Accountant General on deputation basis, subject to court order.

Prof. Amitabh Mattoo added that the issue regarding allotting tender beyond allocated funds be inquired into by the Vice Chancellor. The Vice Chancellor informed that the MHRD/UGC is looking into this matter including recruitment of faculty.
