The Vice Chancellor extended a very warm welcome to the members of the Academic Council as well as the special invitees. He expressed his deep sense of gratitude to the members and the special invitees for sparing their valuable time to attend the 6th meeting of the Academic Council to enrich its deliberations, and to guide the University in steering its academic affairs. He added that the term of first Academic Council expired in March 2015. The MHRD vide their letter F.No.52-7/2013-CU.III dated 6th August, 2015 conveyed the assent of the Visitor regarding composition of 2nd Academic Council and thus the 2nd Academic Council has since then been constituted. The Vice Chancellor also added that during the interim period no meeting of the Academic Council could be held, hence this meeting was scheduled at a short notice to address certain urgent matters.

The Vice Chancellor made a power-point presentation with regard to various academic and developmental activities. The Vice Chancellor informed that during the period under report, the admission process was accelerated and innovative processes were adopted with a view to give wider publicity by using diverse means of communication, such as, print and electronic media, SMS, emails, TV channels, FM channels, FM radio, hoardings, etc. As a result, 8775 applications were received for the Academic Session 2015-16 for the 12 Post Graduate Programmes as compared to 2666 candidates who applied in the previous Academic Session. The admission process was completed and 332 students were admitted to various Post Graduate programmes, while 29 students were admitted to M.Phil-Ph.D. Programmes, as detailed out in the Report. The Vice Chancellor also informed that representation to SC/ST/OBCs were also given as per UGC/Govt of India policy. He further added that the pass percentage for examination for the first semester was 77% and for third semester it was 86.95%. Likewise the pass percentage for the second semester examination of Academic Session 2014-15 was 96% and for fourth semester it was 99.14%. He also highlighted about the number of scholars who qualified JRFs/NET in various Departments.

The Vice Chancellor informed the Council that the University is also providing hostel accommodation to the students in the hired buildings. He further informed that the University is providing Centralised Library facilities having sufficient Books, Thesis and Dissertations, and other facilities like E-journals, E-resources, Full text data bases (ISID, JCC, UGC info net), computerised lab with WiFi, Reprographic services, Reference services, and automation facilities for Research Scholars and students. He also added that the University has NKN connectivity/ campus WiFi enabled/ LAN connections. The University has also created three centralised computer labs with about 70 computers at Temporary Academic Block Campus and a centralised computer

lab with about 50 computers at main campus. He also informed that file tracking system in the Administrative offices has also been started. The Vice Chancellor further informed about the number of faculty positions that have been already advertised and the process for filling up these positions is under progress. He also informed that a number of Non-Teaching posts including the Controller of Examinations/ Librarian and the Finance Officer have also been advertised and action is being taken to fill them. The Vice Chancellor made a mention about the adoption of five villages, Jang Panchayat under Unnat Bharat Scheme, Adoption of two Schools and variety of other initiatives under outreach programmes of the University.

He apprised the Members about the visit of Dr. Jitendra Singh, Hon'ble Union Minister for Development of North Eastern Region (Independent Charge) and Minister of State, Prime Minister Office, Personnel, and Public Grievances & Pensions; Department of Atomic Energy and Department of Space (on 10/05/2015); Professor (Dr.) Ram Shankar Katheria, Hon'ble Minister of State, Department of Higher Education, Govt. of India (on 26/05/2015); Jenab Mufti Muhammad Sayeed, Hon'ble Chief Minister, J&K; Dr. Nirmal Singh, Deputy Chief Minister and other Ministers of J&K State who visited the University campus on 16/10/2015 and appreciated the academic and developmental initiatives taken by the University. The Vice Chancellor also made a special mention about the Memorandum of Understanding (MoU) signed by Central University of Jammu with Central University of Kashmir and Central University of Himachal Pradesh for P.G. Courses, i.e. MBA(Human Resource Management), MBA(Tourism and Travel Management), English, Applied Mathematics, Economics and Education to promote cooperation in educational and research activities, besides establishing a framework for programmes of exchange and collaboration in areas of mutual interest thereby facilitating transfer of credits. He added that the faculty of the University has undertaken number of major and minor projects. He also apprised the members about the various ongoing developmental/construction activities on the campus and thanked MHRD and UGC for their guidance and financial support.

Worthy members of the Academic Council appreciated the Report of the Vice Chancellor and congratulated him and his team for achieving so much within a short span of four years since the functioning of the University. They also appreciated the Vice Chancellor for taking steps to initiate new academic programmes in the emerging areas.

The worthy members gave valuable suggestions to improve the Academic programmes of the University.

- Prof. Dev Raj suggested that since the Central University of Jammu is a new university, it must strive to start programmes in the emerging areas, unlike traditional courses simply rendering a quantitative addition comprising of traditional courses. These must be socially relevant, academically competitive with global standards and catering to the employment sector. He also desired that the permanent Vice Chancellor should have his own vision in deciding about the kind of Courses to be started in the Session 2016-17. The interim arrangement lacks mandate for any policy decision for starting new courses.
- Prof. Devraj informed about the adoption of Choice Based Credit System as per UGC guidelines that the same was earlier discussed in a one-day workshop on CBCS at Srinagar, which was chaired by Hon'ble Governor, J&K and Central University of Jammu actively participated in both these workshops.
- Prof. Sahni appreciated the efforts of University in signing MOUs with other Universities. He suggested that if the third semester is kept free from

core courses, the students can go to other University and complete the elective courses of their choice and come back in the 4th Semester.

- Prof. Sahni also suggested that in the B.Voc programme, a problem may come when different criteria for admission is adopted by different Universities. Prof. Devraj clarified that this aspect will be taken care by the UGC and necessary guidelines would be framed in due course. The Vice Chancellor added that wherever equivalence in terms of qualification is not clear, the matter will be referred to the Equivalence Committee of the University.
- Prof. Sahni also opined that while the proposal for direct Ph.D. is an important initiative, there is need to provide chance to the desirous candidates to seek admission to direct Ph.D. especially for those who may not possess M.Phil., but they should have some comparable published research work to assess their research aptitude.
- Prof. Sahni further suggested that the University may review after one year to see whether external examinations may be dispensed with and the internal examination system may be strengthened and adopted in toto.
- Prof. Mohammad Miyan suggested that apart from Hindi Language, other languages may be started. The Vice Chancellor informed that the University is planning to add endangered language, such as Shardha, etc.
- Prof. Shiv Puri gave a detailed power-point presentation on Nuclear safety. He observed that Indian economy is on fast track, but man power is deficient. He also added that nuclear energy is the best solution to solve the contemporary energy problems as solar energy may not be stored in the required capacity as the sun is not available at all the time.

• It was decided that Sh. Raj Nehru may be requested to prepare skill based market and job oriented short courses for the Central University of Jammu.

• Prof. Devanand urged the Council that the already approved courses in previous Academic Council held on 22nd December, 2014 be also started. However, the overall view of the members was that the University should start new programmes in the emerging areas. Arising out of discussion, it was agreed that the earlier decision was taken during the interim arrangement and hence can be renewed and revisited.

• The Vice Chancellor informed that the Central University of Jammu had recently joint consultative meetings of Central University of Himachal Pradesh and Central University of Kashmir for fruitful academic interaction and to make academic programmes/syllabi socially relevant and to compete with global standards, apart from augmenting employment opportunities.

The Vice Chancellor assured that the aforesaid observations/ suggestions of the worthy members would be taken care while framing the ordinances for direct Ph.D. and on other issues raised by them.

The evaluation pattern was reviewed on introduction of Choice Based Credit System from the session 2015-2016 in a meeting of HODs. The following issues were discussed.

- 1. Continuous Internal Evaluation
- 2. Pattern of Question Paper
- 3. Evaluation
- 4. Grading

In postgraduate courses, three basic components are followed for assessing the performance of the students at different intervals as specified in the academic calendar of the university.

1. Continuous Internal Evaluation: The members highlighted that the performance of the students in three said components remains lopsided when performance of candidates is reviewed in three components (Continuous Internal Assessment + Mid Semester Examination + End Semester Examination) for passing the semester examination.

The students are securing very high marks in each of the component viz., Continuous Internal Assessment (25%), Mid Semester (25%) and End Semester Examination (50%). In the light of this, it was decided to introduce separate passing in Continuous Internal Assessment and Mid Semester in combination and End Semester separately.

The candidate, therefore, is required to obtain 50% marks in Continuous Internal Assessment and Mid Semester Examination in combination and 50% marks in End Semester Examination separately.

The candidate shall be declared to have passed a course(s) of programme if he/she obtains 50% in both the components separately.

The students who have obtained 50% in Continuous Internal Assessment and Mid Semester Examination in combination shall be only eligible to appear in course(s) of the programme in end semester examination.

The candidates getting less than 50% marks shall be given one additional chance to re-reappear in Mid Semester Examination. The eligibility shall be course wise (paper wise) for appearing in end semester examination in a programme of studies.

2. Question Paper Pattern: The second issue discussed was relating to change in the pattern of question papers for Mid Term and End Semester Examination. A Question paper gives coverage to the content of the course(s) through three sections. The section A pertains to Objective Type Questions, Section B pertains to Short Answer Type Questions and section C pertains to long answer type Questions. The changed pattern of Question Papers is submitted as under:

Section B shall consist of ten short answer questions, two from each unit. Each question shall be of eight marks. The candidate is required to attempt any five questions selecting atleast one from each unit (Total 40 marks).

Section C shall consist of five Long Answer Questions, out of which one question pertains to a case study. Each question shall be of fifteen marks. The

The Vice Chancellor approved the decision and accordingly the above said pattern has been followed for the conduct of End Semester Examinations. The model question papers are set on the new pattern and sent to the external examiners for setting the question papers to be used in the 1st semester examinations to be held w.e.f. December, 2015 as part of approved procedure.

3. Evaluation: The Evaluation was completely Internal till the introduction of CBCS. UGC scheme states that 50% of core papers in each semester shall be set and evaluated by External Examiners. The Dean of the school shall decide about 50% of the core papers to be set & accordingly shall appoint the external examiners. In order to declare the results timely, it has been decided to invite the External Examiners to the University who had set the paper and get the answer scripts evaluated. The rates for evaluation have been already approved & the examiners invited shall be paid remuneration on the last day of his/her visit and other logistics associated with visit shall be taken care by the University. In case

any examiner is unable to join, in that event, the scripts will be sent to the examiner with a request to complete the work timely. The other papers will be set & evaluated by internal examiners/teachers who are teaching the course.

4. **Grading System:** The University shall have a Grading System on a ten-Point Scale of Evaluation viz. O, A+, A, B+, B, C, P and F (with Grade Points ranging from Zero to Ten) based on the performance of students in terms of percentage of marks obtained by them in all the papers/courses within semesters of a course of study. For this purpose, the percentage of marks obtained by the students in the examinations of all semesters in a course of study shall be converted first to the respective Letter Grade then to the corresponding Grade Point and Credit Point Obtained by the students. Based on these values, Grade Point Average for every examinee in every semester is calculated. On the basis of Grade Point Average of an examinee in all the semesters in a course of study Cumulative Grade Point Average (CGPA) is computed.

Note: For Non-Credit Courses satisfactory or unsatisfactory shall be indicated in the marks cum grade sheet instead of letter grade and this will not be counted for computation of SGPA/CGPA.

The UGC recommends the following procedure to compute the Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

- i. The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a student in all the courses taken by a student and the sum of the number of credits of all the courses undergone by a student, i.e SGPA (Si) = ∑(Ci x Gi) / ∑Ci where Ci is the number of credits of the ith course and Gi is the grade point scored by the student in the ith course.
- ii. The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme, i.e. CGPA = \sum (Ci x Si) / \sum Ci where Si is the SGPA of the ith semester and Ci is the total number of credits in that semester.
- iii. The SGPA and CGPA shall be rounded off to 2 decimal points and reported in the transcripts.

For the successful completion of the Master Degree Programme in a Course of Study, a student must secure a CGPA of at least 4.0 point.

- A student obtaining Grade F shall be considered failed and will be required to reappear in the examination.
- ii. For non credit courses 'Satisfactory' or 'Unsatisfactory' shall be indicated instead of the letter grade and this will not be counted for the computation of SGPA/CGPA.

A student who has successfully completed all the courses to accumulate the minimum specified number of credits under the Choice Based Credit System shall be deemed to have completed the Programme of Studies.

Marks-Grade Card: Marks-Grade Card shall be prepared by the Controller of Examinations' office at the end of the Semester and dispatched to the candidates within five days of the declaration of the result. The marks-grade card shall contain the following:

- 1. Course Credits Registered
- 2. Course Credits Earned
- 3. Grade
- 4. Grade Point Average (GPA)
- 5. Cumulative Grade Point Average
