Clause 3 of Ordinance no. 15 states that:

"The Board of the Research Studies under the overall guidance and supervision of the Academic Council shall perform following functions:-

I. determine the priority areas of research to be undertaken in various departments / centers in consonance with role and responsibility of the University and also create facilities where ever necessary for core thrust areas of research in each department;..."

At present, the University has been sanctioned 61 Research Projects by various external funding agencies like SERB, ICSSR, IUAC, DRDO etc. 165 Ph.D. Scholars and 28 JRF / Research Fellows / Project Assistant are pursuing Research in the University.

All Heads of Departments and Directors of Centres may apprise priority areas of Research in their respective Departments and Centres to Board of Research Studies.

The matter is placed before Board of Research Studies for consideration.

To consider guidelines for preparation of Synopsis, format of Thesis etc. for Ph.D. Degree in the University

The University at present has 165 Research Scholars pursuing Research in various Departments and Centres whereas 92 Scholars are likely to join during Academic Session 2020-21. In this regard, it becomes important that guidelines for preparation of synopsis may be deliberated upon so that uniformity in the preparation of synopsis may be ensured. Draft guidelines are attached herewith as **Annexure – I**. Similarly, a fixed format of thesis / dissertation may be considered by the Board of Research Studies.

Suggested guidelines and approved format of thesis etc. may be placed before forthcoming Academic Council for approval.
