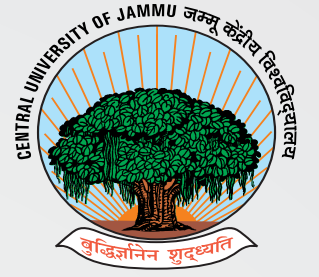

## *Vision & Mission*

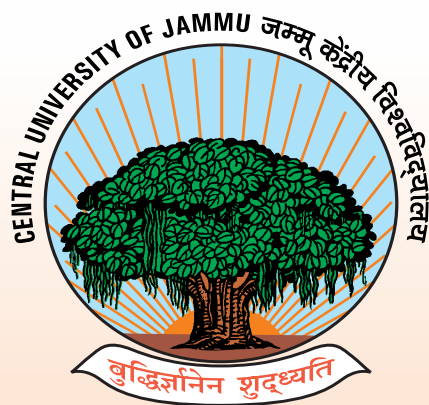
### *Vision*

## Campus at a glance

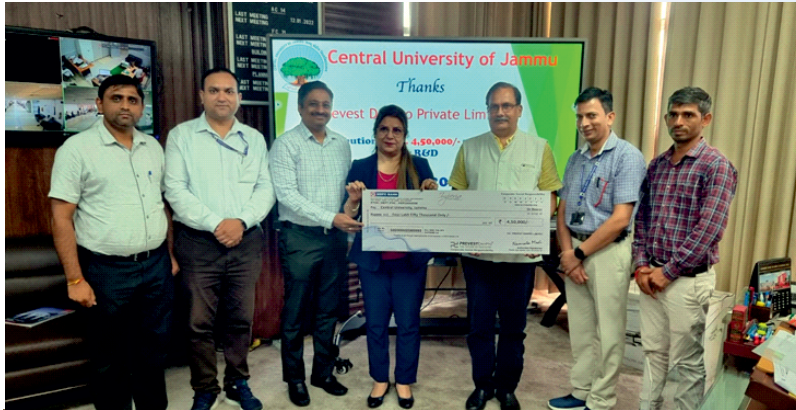
### Introduction

The Central University of Jammu (CUJ) came into existence on August 08, 2011 and was established under the Central Universities Act, 2009 (Act No.25 of 2009 read with the Central Universities Act, 2009). The first academic session (2011-2012) commenced with three post graduate courses and at present university is offering various undergraduate/ Postgraduate/ PhD/ Diploma/Certification programmes through its University Departments and Centres. The University is located at Village Rahya – Suchani (Bagla) in District Samba of J&K, approximately 24 km away from the Jammu-Tawi Railway Station, 25 km from the Jammu Airport, and around 7 km from the National Highway. The campus is well connected through local and state transport. Central University of Jammu epitomizes an inclusive and pluralistic institution of higher learning. The faculty and students as a collective community is committed to discovering and sharing knowledge, as well as addressing the challenges that our world is facing.



The university's administrative office is housed in a building at the campus site at Rahya-Suchani (Bagla), Distt-Samba, (J&K). The university campus area extends to 610-acre which comprises a variety of noteworthy geographical characteristics, including a scenic environment, various buildings, and large roads. The campus is a sight to behold, with architectural harmony and natural beauty. The main academic building houses various teaching, research, library, laboratory and recreational facilities.

# Academic Highlights

Central University of Jammu is slated towards striving excellence by focusing on various aspects that elevate the status and stature of education. A sound reflection with the changing times is the utmost intention of a growing institution. All programs offered by the University are in a state of continuous re-orientation and revamping in consonance with the New Education Policy, 2020. To ensure this, the University has ensured the following:

## **Innovative Programme Design**

The University's Programmes have been created with the goal of making students worldwide competitive in their respective disciplines. The focus is on the 'Learner-Centric Approach' as opposed to the conventional 'Teacher-Centric Approach' to accommodate learner's needs and expectations to have wider choices in content, mode and pace of learning.

## **Adoption of Inter-disciplinary Approach of Learning**

Each study program of the University is inter-disciplinary in approach as the student is empowered to accumulate required number of credits from a wide variety of courses offered by other Departments of the University. Cross-disciplinary study gives exposure to students in terms of holistic conceptualization of the realms of learning.

## **Academic Calendar based on Semester System**

All academic programmes of the University viz. Certificate, Diploma, B.Voc, Undergraduate (UG), Post Graduate (PG) are based on semester system, designed at par with global practices to encapsulate a more structured pattern and effective number of teaching days along with adequate teaching-learning inputs.

## **Inclusion of Comprehensive Choice Based Credit System**

The University is following Comprehensive Choice Based Credit System (CBCS) as per UGC norms largely on the lines of the best Universities of the world.

## **Holistic Evaluation System for Academic Programs**

Students enrolled in all disciplines of study are assessed through Continuous Internal Assessment based on quizzes, field projects, assignments, independent works, group work, Mid-semester and End-semester examinations. Each Department offers minimum three activities out of a list of activities to assess the performance of the students through wide variety of activities under Continuous Internal Assessment to holistically evaluate the students.

## Evaluation Process for all Academic Programmes

Assignments, independent tasks, group work, mid-semester, and end-semester exams are used to assess students in all courses across disciplines at all levels. Each department provides a minimum of four activities from a list of activities to measure students' performance through a range of activities as part of a continual internal assessment process. The following steps make up the assessment process:

Continuous Internal Assessment	25%
Mid-Semester Examination	25%
End-Semester Examination	50%

## Fellowships for PG and PhD Students

Fellowships are the most important part of student support. Central University of Jammu assist the students and researchers in availing these fellowships by providing guidance to the students for clearing the National level exams for the fellowships. Researchers who are pursuing PhD and those who have cleared their UGC (JRF)/ GATE are availing the fellowships offered by University Grants Commission and Council for Scientific and Industrial Research. Various other fellowships availed by the University students are NGOBC, RGNF, Single Girl Child, Pahari Speaking, Post Matric Scholarship for SC/ST students, PMS-Minority etc.

## State-of-the-art Facilities

The University offers various facilities on campus including library, gymnasium, canteen, hostel, sports facility, wi-fi connectivity and much more. The campus is both eco-friendly lush green and inviting equipped with all necessary facilities. Students enrolled in the University can benefit from these facilities without paying any membership charge.

## Internship Embedded Skill Training Programme

The goal of this initiative is to provide Indian youth with skill training through sector-specific vocational education programmes. The Next-Generation Bachelor of Vocational [B.Voc.] programmes are offered under the University Grants Commission's (UGC) "National Skill Qualification Framework (NSQF)" to address critical knowledge and skill-set gaps required to make candidates "Industry Ready" and also shape "Young-entrepreneurs." The Bachelor of Vocational [B.Voc.] programmes incorporate specific job roles and their equivalent National Occupational Standards (NOSs) along with

broad-based general education. The Central University of Jammu currently offers three B. Voc. programmes namely B. Voc. (Tourism Management), B. Voc. (Retail Management) and B. Voc. (Banking & Finance). The three-year degree programme begins with a Diploma course leading to a Bachelor of Vocational Degree [B.Voc.] in the 3rd year. B.Voc. programme offer multiple entry and exit options. As a course requirement, every B. Voc. student of Central University of Jammu is required to complete internships through 'Earn While You Learn' model. This 'Earn While You Learn' model provides students an opportunity to earn a modest stipend in skill knowledge sectors.

### Opportunity for International Students

The overseas students desirous of seeking admission in various programmes will be given the opportunity to apply for admission under “Provisions for admission to International Students”.

### Quality Education at Affordable Fees

Central University of Jammu has relatively low tuition fee that students from any background can afford. A major advantage of attending Central University of Jammu is that the fee of any programme is not excessively expensive for students to avail good quality education



# State-of-the-art Infrastructure

To meet the contemporary demands of many programmes, the University boasts state-of-the-art infrastructural facilities such as smart classrooms, well-equipped Research Laboratories, and Lecture Theatres. The University has a fully automated library that is stocked with an adequate number of books (both physical and electronic), journals (both physical and online), and reference materials relating to the many disciplines/programs of study provided by the University.

## Internet & ICT Labs

The University is equipped with seamless Wi-Fi connectivity and students can access the Internet through their own laptops from anywhere in the Campus. The University also has three state-of-the-art ICT Labs equipped with high-end PCs loaded with necessary software's accessible to the students of all the disciplines.



## Gymnasium

The University has established fully equipped gymnasium in the Main Campus.



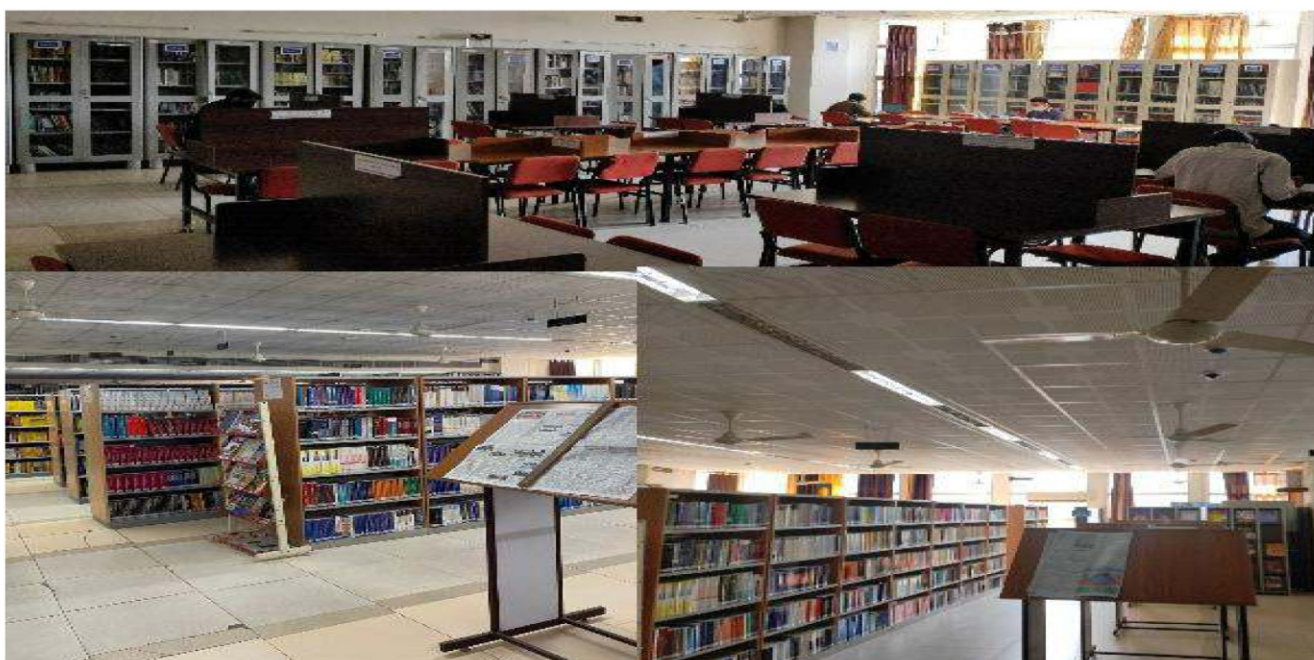
## Seminar Hall

Well-equipped Seminar Hall with a seating capacity of 170 has been created. The Committee rooms are available for conducting official meetings, Seminars and/or other academic activities.



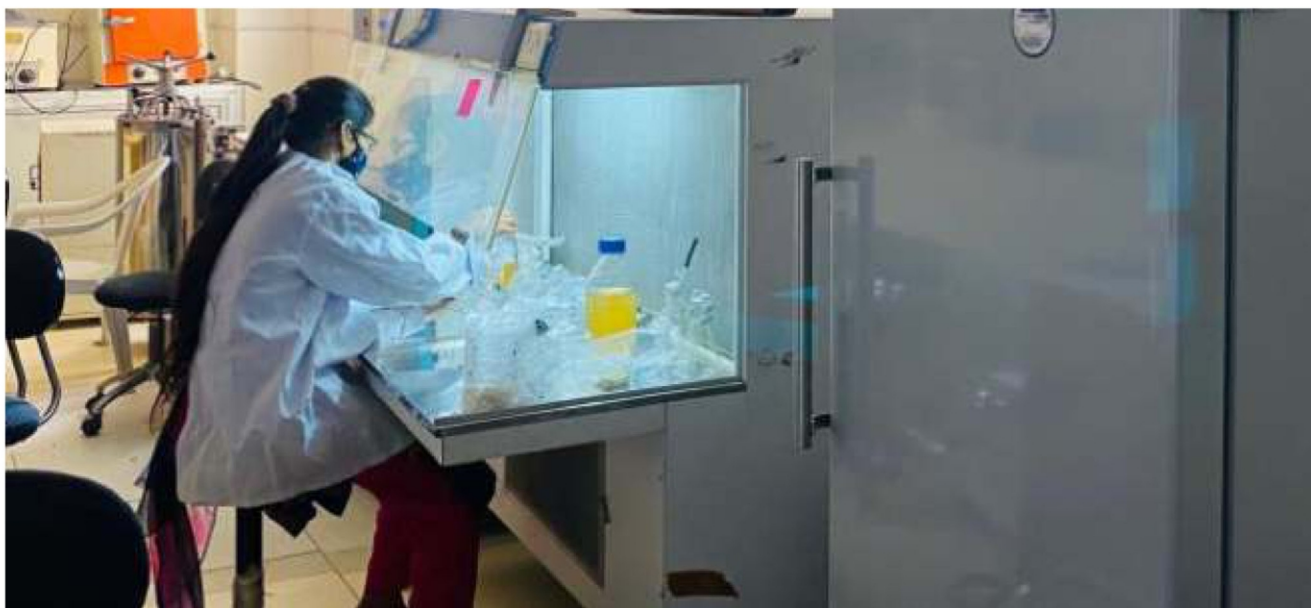
## Library

The library was established in the year 2011 and now catering 21 departments. It has a collection of 27253 Books, 50 print journals, 5118 online e-journals, 277 e-Books, 16 Newspapers, 15 Magazines and remote access facility for accessing subscribed e-resources through INFED (INFLIBNET). The Library has 10 Computers for Research Scholars and Students to access the e-Resources, Internet and OPAC. The library has access to anti-plagiarism software namely URKUND and iThenticate (Turnitin).



## Laboratories

University provides state of the art laboratory facilities to its students, faculty and staff for carrying out teaching, research and practical activities. The University has dedicated labs for various disciplines of sciences.



## Healthcare

Medical facilities with full time Doctors and nursing staff are available for the students, staff and faculty of the University at its campus.



## Canteen/Cafeteria

The University has a spacious, airy canteen where students and teaching faculty get an opportunity to relish the neat and clean eatables prepared under hygienic conditions at its campus.



## Language Lab

To enhance the communication competence of students, a software-based language laboratory caters to the needs of students. Various sessions on listening, speaking, and writing enable learners to develop proficiency of English language. The software is flexible in nature which the concerned faculty appropriates keeping in view the proficiency level of learners. Moreover, software related to vocabulary building upgrade academic communication of students. Significant thrust on audio-visual display also ascertains effective communication strategies.



## Banking and ATM Facilities

University provides banking facilities to its faculty and students for all kinds of transactions. For the convenience of staff and students University campus houses branches of J&K Bank and SBI. ATMs of HDFC and J&K Bank have been installed at the main campus building to facilitate students and faculty.



## Directorate of Physical Education

Directorate of Physical Education was established in the year 2018 with an objective of developing and promoting sports culture among the youth for overall development of their personality. The directorate aims to develop spirit of sportsmanship, achievement, national pride and patriotism among youth. With a view to realize and fulfill this mammoth task, the Directorate plans to develop the sports facilities and infrastructure in the campus and conduct camps, marathons, university campus sports activities etc. Students brought laurels to the institution by winning a number of state and national level competitions. The Directorate of Physical Education has constituted a 'Fitness Club' that regularly organize the activities which promotes the vision of Fit India Movement. Students of Central University of Jammu participated in various sports events like All India inter University sports championship, State sports championship etc.



# University Business Incubation Centre

The University Business Incubation Centre (UBIC) was set up in the Year 2015 under the aegis of Innovation, Incubation and Entrepreneurship Council sponsored by M/O MSME, GOI to foster a culture of entrepreneurship amongst students as well as local population. The aim and the focus of the Incubation Centre is to nurture innovative ideas for commercialization and provide infrastructural support to incubates. UBIC nurtures the innovative ideas of existing and prospective entrepreneurs in emerging innovative ventures by providing necessary mentoring, promoting IP ecosystem and providing the entrepreneurs a platform to commercialize their ideas besides helping to raise the seed capital from different financial institutions at subsidized rates and IP protection. Also, Campus Start up track has been initiated for promoting innovation. An amount of annual cash prize of Rs 25000/- has been announced by UBIC for promoting best innovative idea shaving commercial relevance. In order to create awareness about entrepreneurship and sensitizing students about various schemes of GOI a Lecture Series has been initiated by the UBIC and UIC wherein experts from diverse fields along with successful entrepreneurs are invited to deliver lectures. Guided by the reforms agenda in higher education and learning from the experiences of the best Universities of the world, the University has introduced a number of innovations.

## Industry-Academia Interface

The University has signed MoUs with industry, reputed Institutes /Universities within the country and abroad which include MoUs with Chamber of Commerce and Industries, Jammu, VLCC, NASSCOM Foundation, New Delhi, Ashray Incubator, Ahmedabad, ASCI, Hyderabad and the University has also obtained membership of apex industry bodies viz. ISTD, IAOTA, CII, NHRDN, AIMA, United Nation Academic Impact (UNAI) etc. This linkage has resulted in creation of a strong industry-academia interface for the benefit of the students and faculty. The University has initiated eminent lecture series where in prominent personalities who have contributed in the irrespective fields are invited periodically for interaction with students and faculty.

In 2017, the University organized a three-day HRD Congress with an objective to strengthen the links between University and Corporate Houses. The event witnessed participation of industry leaders from almost 30 corporate(s). Keeping in view the limited available industrial exposure for the students of J & K, the event not only provided the platform to the students of CUJ but also to other academic institutions of the region. Through this event the University was able to provide corporate guidance and training for students and faculties across the disciplines. Furthermore, through HRD Congress the University was able to generate training, mentorship and placement avenues for faculty and students respectively.

The University has also initiated a unique “Corporate Immersion & Leadership Development Programme” with an objective to sensitize the professionals for under

standing of the industry at grassroots level that attempts to connect classroom learning with real time environment.

## **Office of International Affairs**

Central University of Jammu aspires to enroll international students and for this the University has an active Office of International Affairs (OIA), which is responsible for developing a coherent strategy to promote Central University of Jammu's international relations, global profile and international competitiveness. The university is in process of attracting overseas students from next academic session.

About OIA: Central University of Jammu accords high priority in attracting the international students from various key countries and is evident in the form of university's policy initiative by establishing institutional structure The Office of International Affairs (OIA) working with the mandate of regular functional cell in university, under the direct supervision of the Hon'ble Vice-Chancellor. In terms of explicit policy initiatives the University has been proud member of United Nations Academia Impact (UNAI) of United Nations, joining more than 500 Institutions' association. The University intends to attract the students from various countries, from SAARC region, Nordic and European countries, and accordingly the Office of International Affairs is devising a priority strategy action plan for University out-reach programmes engaging with various International agencies working in the areas of Higher Education for Regular Students enrolment as priority, apart from developing on-line courses, in various courses offered by University. The Office of International Affairs is trying to work with 'Education attaches' of various Diplomatic mission and Central agencies.

Plan of Action (PoA) for targeting International Students: The regular courses offered by the Central University of Jammu, are in tune with the international standards offered by any other Indian Universities, further as per the direction of the Ministry of Human Resource Development, Government of India direction from time to time, various Departments are devising on-line courses keeping in view the domain specialisations. The Office of International Affairs is developing ambitious course structure in collaboration with various International agencies working in India on the Study in India Program (SIP) focusing special component on the Jammu & Kashmir State, to attract students from Europe and North America for short-term courses. With the objective of making the university unprecedented visibility at the international level, attempts are being made to undertake joint research and teaching projects that allow credit transfers and grant of joint degrees to students in areas of mutual benefit.

## **Inception**

1. The Office of International Affairs (OIA) was set up in February 2016, in the Central University of Jammu, to accord high priority for attracting the International Collaborations and students from across the key countries, this resolve was taken forward in the form of university's policy initiative by establishing Institutional

structure as Office of International Affairs (OIA) working with the mandate of regular functional cell in university, under the direct supervision of the Hon'ble Vice-Chancellor.

2. Motto: 'Collaboration helps Knowledge benefit the Society'
3. Vision: "To make academic diversity worldwide with international collaborations and competent learning as the cradle for the Central University of Jammu so as to cultivate defining element of knowledge led international education and research as the priority strategy through high quality promotion and sustenance initiatives."
4. The (OIA) in terms of its explicit policy initiatives has registered the Central University of Jammu as proud member of United Nations Academia Impact (UNAI) of United Nations, joining more than 500 International Institutional association making it more visible. The Office of International Affairs strategy is to develop International academic engagements working for materializing Collaborations, Agreement of Cooperation and MoU's with various Foreign Universities approved by various Regulatory bodies like MHRD, UGC, ICSSR, and AIU.
5. The (OIA) is moving forward of attracting foreign students from various countries, focusing on SAARC region, Nordic and European countries in upcoming Academic sessions and accordingly the Office of International Affairs is devising a priority strategy and programme of action for University global out-reach and engaging with various International agencies working in India.
6. The Office of International Affairs (OIA) has already initiated working with 'Education attaches' of various foreign diplomatic mission and Central agencies with the encouragement from the university leadership.
7. The regular post-graduation courses offered by the Central University of Jammu, are in tune with the International standards offered by any other Indian Universities, further as per the direction of the Ministry of Human Resource Development (MHRD) Government of India, from time to time various departments are devising On-line courses keeping in view the domain specializations. The Office of International Affairs (OIA) is focusing on developing ambitious course structure in collaboration with Nordic Centre in India on Study in India Program (SIP) with special component on the Jammu & Kashmir State with advantage of its diverse cultures and geographical uniqueness to attract students from Asia, Europe and North America for short-term/long term courses.
8. OIA Strives for making the university's unprecedented visibility at the International level by engaging with various International Universities for knowledge exchange. Attempts are being made to undertake joint research and teaching projects that allow credit transfers and grant of joint degrees to students in areas of mutual benefit.

# Co-Curricular Activities

Co-curricular activities enhance student learning by stimulating creative thoughts, improving social and organizational skills, developing interest and talents and providing students with the opportunities to unwind and to do something that they really enjoy. In order to cater the needs of the students' various co-curricular activities are organized by various departments/cells at the University Campus.

## Participation of students in State and National level championships

Students of Central University of Jammu participated in various sports events like All India University Sports Championship etc.

## Udaan

University organizes Annual Cultural Festival UDAAN where students showcase their talents in various areas like Singing, Dancing, Painting, Rangoli, Photography etc.



## NSS Activities

The National Service Scheme (NSS) Unit was created in the Central University of Jammu in 2015 in order to engage students in the co-curricular activities such as community development and awareness programmes. So far, the Unit has enrolled more than 120 volunteers from various Departments of the University. It has organized various activities: Blood Donation Camp, Visit under PRA (Participatory Rural Appraisal), Participation in Youth Festival, Republic Day Celebrations, Digital India Workshop etc.



## NCC Activities

NCC Directorate JK&L Introduced NCC in Central University Jammu in November 2020 by allotting hundred (100) Senior Division Boys unit in the University, as a part of newly raised 4th J&K Battalion NCC Group Headquarters Jammu which spreads over Samba and Kathua Districts of the border area. Since introduction of NCC unit in Central University of Jammu various initiatives towards NCC has been taken over such as : Celebration of NCC day , Celebration of Constitution day , NCC Unit of Central University, Jammu participated in Azaadi ka Amrit Mahotsav to celebrate the contribution of freedom fighters and above all Central University of Jammu recognizing the



importance of NCC in shaping the youth of the country to become the front warrior to respond the conditions of crises in the country incorporated NCC as a “General Elective Credit Course” under the Choice Based Credit System, in line with NEP 2020 from the upcoming academic session 2023-2024.





# HOSTEL FACILITIES

The University has comfortably-furnished boys and girls hostels which make for a good home away from home. **Girls Hostels** are hired private buildings to accommodate outstation students on the basis of merit and distance. Dr. Syama Prasad Mookherjee **Boys Hostels** is fully functional within the campus premises at Rahya Suchani. Each block has a fixed capacity. Both boys and girls hostels are happening premises and are provided with all basic **facilities** including water coolers with water purifiers, washing machines, common TV room, common reading room and recreation room. The hostel life is culturally vibrant and socially secure for students.



# Student Support

## Equal Opportunity Cell

Equality of opportunity is one of the most important principles of constitutional democracy in India. Central University of Jammu ensures every person an equal opportunity at all levels irrespective of any caste, religion, race, creed, gender, sexual orientation, gender identity, gender expression, marital status, age, minority, economically weaker section or disability. The objective of the cell is to create conducive atmosphere for healthy inter- personal relation among students from different sections. The CUJ promotes diversity and inclusive practices within the campus.

## Training & Placement Cell

The Central Placement Cell of Central University of Jammu endeavors to facilitate and provide suitable placement to students in reputed multinationals, Government Organizations, NGO's and the private sector. It is in touch with leading national and multi-national companies. The University prepares the students for the industry by providing them pre-placement training and skills. The University has full time TPO and there is phenomenal rise in the placement packages.

## Students Progression to Higher Education

Many students of Central University of Jammu are pursuing higher degrees in good institutions like Delhi University, Hanyang University (South Korea), ENSCBP Bordeaux (France), Jamia Milia Islamia, Punjabi University, MANNU (Hyderabad), University of Estonia, IIT Jodhpur, NIT Srinagar, Central University of Rajasthan, IIT Indore etc. Our students are showing excellence in their careers by pursuing their higher education from all these reputed institutions.

## Combined Coaching Classes for Competitive Exams

The University is also providing coaching for Competitive exams like, UPSC, JKPSC, BANKING etc. to the aspiring students (including those belonging to SC,ST,OBC, PWD & EWS categories) for different competitive examinations under Dr. Ambedkar Centre for Excellence(DACE).

## Students' Grievance Redressal Committee

The University has constituted a Students' Grievance Redressal Committee to address the issues, concerns, and complaints filed by the students at any point in time. This

student grievance redressal mechanism provides students essential support to resolve their issues either academic or non-academic in nature. A grievance redressal committee headed by academic coordinator has been constituted to tide over the difficulties if any raised by the students. A suggestion box has been kept for seeking opinion of the students. Many changes have been done on account of the same viz. Library timing changes, internet facility extended, bandwidth extended, wi-fi facility provided in hostels, improvement in the food quality in canteen as well as in mess. There is a cell named GSCASH (Gender Sensitization Committee Against Sexual Harassment) under which university is having University Complaints Committee (UCC) in order to address the issues and complaints filed by the student or employee of the university. Equal Opportunity Cell also addresses the issues and complaints of the university fraternity. The university ensures every person an equal opportunity at all levels irrespective of any caste, religion, race, creed, gender, sexual orientation, gender identity, gender expression, genetic information, marital status, age, minorities, economically weaker section or disability.

## **Anti-Ragging Measures**

The University is committed to prevent ragging and an anti-ragging Committee has been constituted in accordance with the relevant Supreme Court guidelines.

### **What constitutes Ragging**

- Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof to any fresher or any other student.
- Asking any student to do any act which such student will not in the ordinary courses do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
- Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.

- Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students. Any act of financial extortion or forceful expenditure/burden put on a fresher or any other student.
- Any act of physical abuse including all variants of it: Sexual abuse, homosexual assaults and stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
- Any act or abuse by spoken words, emails, posts, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student

#### **Administrative action in the event of Ragging**

- Suspension from attending Classes and Academic privileges.
- Withholding/Withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any Test/Examination or other Evaluation process.
- With holding results.
- Debarring from representing the Institution in any Regional, National or International Meet, Tournament, Youth Festival etc.
- Suspension/Expulsion from the Hostel.
- Rustication from the Institution for period ranging from one to four Semesters.
- Cancellation of Admission.
- Expulsion from the Institution and consequent debarring from Admission to any other Institution for a specified period.
- Filing of First Information Report (FIR) with the Police and Local Authorities, under the appropriate Penal Provisions.

## **GSCASH (Gender Sensitization Committee against Sexual Harassment)**

Gender sensitization against Sexual harassment in campuses is a sine qua non of peaceful and respectful living. Sexual harassment can happen at work places, institutions, in the family or on the streets. Even in an enlightened institution like a university campus sexual harassment cannot be very uncommon. With the aim of constituting a legally formalized Cell to address gender issues, the gender sensitization committee against sexual harassment (GSCASH) in Central University of Jammu has been constituted.

# ADMISSION 2023-24

## General

Admission (for the session 2023-24 to all the Programmes of studies shall be made on the basis of merit through Central Universities Common Entrance Test (CUET) to be conducted by National Testing Agency

In some courses the University may Conduct its own Entrance Test subject to approval of Competent Bodies of the University after conduct of (CUET)

For making admission to B.Voc.Programmes and Programmes of Studies under Community College the University shall follow the relevant UGC guidelines/regulations that may be in addition to/ apart from the merit obtained through (CUET) in the respective courses.

## Completion of Admission Formalities

A candidate shall be considered as admitted to a Programme of Study and be eligible to be bonafide student of the University only after he/she has completed all the required formalities for admission including payment of the prescribed fees.If a candidate fails to complete the admission formalities by the prescribed date, he/she will automatically forfeit his/her right for admission.

List of selected candidates shall be displayed on the **University Website. No intimation to the selected candidates will be sent by post.**

The candidates shall be required to get their admissions completed by the dates as notified by the University from time to time and the candidates are advised to remain in touch with the University website [www.cujammu.ac.in](http://www.cujammu.ac.in) and other Admission related website that may be launched by the University (students are advised to be in regular touch with University website [www.cujammu.ac.in](http://www.cujammu.ac.in) for further updates). The selected candidates shall be required to produce, for verification at the time of reporting / last date prescribed for completion of the admission formalities, as the case may be the original documents thereof. In case of a candidate who is already in employment, No Objection Certificate (NOC) from the employer clearly mentioning that the employer has no objection in the candidate"s selection/admission for pursuing higher education in there spective discipline/Programme of study in the Central University of Jammu on regular basis.Such candidate (s) will be considered for admission only on production of a

certificate from the employee that he/she has been granted leave for the prescribed duration in the University. In case of a gap between the qualifying examination and the year seeking admission in the University for more than one year, the candidate shall be required to submit an undertaking indicating the reasons for such gap and the activities in which he/she was engaged during the intervening period.

Only those candidates whose results of the qualifying examination is clear in all respects on the last date prescribed for admission in the University will be considered for admission to a Programme of Study. This year due to COVID-19 Pandemic, the relaxation in submission of qualifying degree will be as per UGC guidelines. Each candidate admitted to a particular Programmes of study/discipline shall be required to submit his/her Migration Certificate in original within the prescribed time frame failing which his/her admission in the University shall stand cancelled. Degrees obtained through distance education mode and off- shore campus/study center will be valid only if they are issued in accordance with relevant regulations, guidelines and instructions issued by the Distance Education Council, UGC, AICTE&AIU.

**Candidates desirous of seeking admission to a Programme of Study in the Central University of Jammu are advised, in their own interest, to ensure that they have inserted the correct code of Central University of Jammu and the subject code allotted to a subject offered by the University, otherwise they will not be considered for admission by the University.**

## **RESERVATION OF SEATS IN ADMISSION**

1. The University shall follow reservation in admission as mandated under the Central Educational Institutions (Reservation of Seats) Act 2006, as amended from time to time.
2. \*The University shall also follow reservation in admission in all Programmes of Study in accordance with the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 and The Rights of Persons with Disabilities Act, 2016.
3. Accordingly, the University shall reserve seats in all Programmes of Study for admission as under for the students belonging to:



Scheduled Caste (SC) Category	15.0%
Scheduled Tribe (ST) Category	7.5%
Other Backward Classes(OBC) Category– Non-creamy layer	27.0%
Persons with Disabilities(PWD)	5.0%
EWS (Economic Weaker Section)	10%

4. Persons suffering from not less than forty per cent (40%) of any disability as certified by a competent medical authority would be considered for admission under PWD category.
5. The candidates applying under the reserved categories shall need to submit the category Certificates (SC/ST/OBC Non-Creamy Layer Certificate/ EWS/PWD issued by the competent authority in the prescribed format at the time of submission of Application Form and produce the same in original for verification at the time of admission/registration. Non-Creamy Layer certificate should not have been issued earlier than six(6) months from the date of registration.
6. If a candidate in there served category qualifies for admission in the general category he/she shall be treated as a general category candidate. If sufficient number of candidates are not available to fill up the seats reserved for Scheduled Tribes, these may be filled up by suitable candidates from Scheduled Castes and vice-versa. If sufficient number of candidates are not available to fill up the seats reserved for OBCs, these may be filled up by suitable candidates from General Category.

Explanation: For the purpose of calculation of number of seats under a reserved category, fractions will be ignored.

Candidates seeking admission under reserved categories shall be required to fulfill the prescribed conditions of admission criteria of the Programme of Study offered by the CUJ.

**Other Supernumerary Seats: One seat each shall be reserved for:**

- a) Outstanding Sportspersons viz: sportspersons of State/National/International repute insuitable courses to promote sports in the university
- b) National Cadet Corps
- c) NSS
- d) Wards of serving or retired Defense personnel as per national policy
- e) Wards of Central University of Jammu employees who are holding or have held substantive post.
- f) Single Girl child.
- g) Kashmiri Migrant

**Admission Criteria**

**Graduate/Master's Degree Programmes**

Admission to all Programmes of studies shall be based on the merit of the students in Entrance Test obtained in (CUET-2023). No candidate under these provisions shall be considered for admission unless he/she has appeared in the (CUET-2023).
