1.4 Admissions

- The Central University of Jammu has been admitting students in various departments since its establishment i.e. w.e.f. August 8, 2011 in collaboration with collegium of 09 Central Universities, (CU Punjab, CU Kashmir, CU Tamil Nadu, CU Kerala, CU Haryana, CU Rajasthan, CU Jammu, CU Karnataka and CU Jharkhand). Central University of Rajasthan continued to be the Nodal University for conducting entrance test through CUCET for 2016-17. The same practice is to be followed for the session 2017-18 for which preparation and process for admission has started.
- In the academic year 2015-2016, the University Offered 13 post graduate programmes. Out of a total of 390 seats for students, 332 students (approx) had been admitted in PG Programmes while 29 students were admitted in various Integrated M.Phil.-Ph.D. Programmes, as shown in table:

- In Central University of Jammu, admissions in 2016 were offered in thirty four courses; Diploma (01), Integrated M.Sc./ P.G. programmes (19), Degree courses (02), and Ph.D. in 12 courses.
- The University made publicity in its efforts to reach out to students/candidates across the country through various means like sending SMS and e-mail to graduates and +2 students encouraging them to seek admission in different courses being run in CUJ. Moreover, posters, pamphlets, banners and hoardings were also used in order to enable the public to learn about the courses being run in CUJ. The faculty visited different educational institutions and made presentation about the university. In the session 2016-17, the University has started integrated five year courses in four science streams of Zoology, Botany, Chemistry and Physics, two new PG courses such as M.Sc. (Material Science & Technology) and MBA (Supply Chain Management) and two Research Centres i.e Molecular Biology and Comparative Religions and Civilisations have also been set up.
- In total 9877 applications were received for the academic session 2016-17 against 8777 in 2015-16 from across the country for various programmes offered by Central University of Jammu. An all India level Entrance Test was held on May 21st and 22nd, 2016. The admission process adopted both online and offline mode.

D. Reprographic Services

The Central Library provides photocopy service to users at nominal rate at both the campuses.

E. Reference Service

The Central Library provides the directional assistance in locating the books and other reading materials in the library.

F. Library Automation

The Central Library is fully automated with open source library automation software KOHA. All the records pertaining to books and users are uploaded in it. The library management software covers acquisition, cataloguing, circulation and OPAC. The OPAC (Online Public Access Catalog) facilitates searching of books by Accession number, title, author and keyword.

G. Membership

The Central Library is a member of DELNET (Developing Library Network) New Delhi. The membership helps the faculty, research scholars and students to locate the books through the union catalogue of books created by the network as it has developed the network of libraries across the country facilitating smooth interlibrary loan activities.

INFLIBNET membership provides access to URKUND anti-plagiarism software. The Shodh Ganga project of INFLIBNET provides access to electronic theses and dissertations.

The Central University of Jammu took possession of the entire stretch of land measuring 4880 Kanal 19 Marlas which was handed over by the State Govt.to the university. The University has undertaken the following works for development of the permanent Campus in the first phase at Rahya-Suchani (Bagla) in Samba These developmental works amount to an expenditure to the tune of Rs.478.71 Crores which (includes of PMC and Architects fees) are in different stages of execution.

State Government apart from providing land free of cost, is required to provide basic infrastructural needs of Access Road, Water Supply, and Power Supply up to the periphery of the University. The cost incurred on account of supply of water/Electric System at the campus of Central University of Jammu is to be borne by MHRD as special dispensation to the CUJ and Budgetary Provision of Rs. 24.70 Crores on account of the cost projected by Ministry of Higher Education has been kept in the budget of 2016-17. In order to kick start the process, the State Government has released Rs. 3.00 Cr from the Revolving Fund to both the line departments of PHE and PDD. The Electrical Poles from Bari Brahmna upto the Periphery have been installed by PDD and tenders for deep drilling of two number of tube wells have been invited by the PHE.

However, keeping in consideration the target of achieving 5-star GRIHA rating, the University has submitted DPR amounting to Rs. 95.42 Cr to the Ministry of New and Renewable Energy for generating Solar Power of 5.46 MW through Solar Yards and 6.11 MW through Roof Top SPV Generation. In order to meet the immediate requirement of 1.45 Mega Watt, a DPR at a cost of Rs. 11.96 Cr has been submitted to the State Government for seeking consultancy with regard to the installation and Commissioning of the Grid Connected Roof Top Photovoltaic Power Plants on the roofs of various buildings in the CUJ campus.

Meanwhile, Project Management Consultancy (PMC) of the University (EPIL) was requested to take up the construction and commissioning of deep drilled Tube well including supply & installation of mechanical and electrical equipments for assured water supply on the basis of report of Central Ground Water Board (CGWB). The work for construction and commissioning of tube-well including supply and installation of mechanical and electrical equipments for assured water supply was awarded to M/s Chenab Infrastructure Pvt. Ltd Jammu for an amount of Rs. 1.15 crore by PMC. The tube well had been commissioned and taken over by the University on13th of April, 2016. Since then the University is not only saving a recurring expenditure of about Rs. 60,000PM but also generating revenue by supplying water to the construction agencies on payment basis. Till date the University has sold the water of approximate amount of Rs. 41 lakhs to the construction companies (on account of filling only).

[B] New Proposals

(i) To shift Temporary Academic Block which is functioning from a rented accommodation at Sainik Colony to permanent Campus at Bagla, it is proposed to take up construction of two Academic Blocks i.e. School of Life Sciences and School of Basic and Applied Sciences with a plinth area of 32450.47 sq. m and 26847.87 sq. m respectively. The tentative cost for the two blocks is Rs. 242 Crores (Rs. 133 Crores for School of Life Sciences and Rs. 109 Crores for the School of Basic and Applied Sciences) and is expected to take a period of 02 years for completion. The PMC as per the directions of CUJ has uploaded the tenders vide NIT No: DLI/CON/696/553 and DLI/CON/696/554 on the website with 16.01.2017 as the last date for submission of bids.

- (ii) <u>Boundary Wall:</u> An amount of Rs. 35 Crores has been released recently by UGC for construction of Boundary Wall.
- (iii) School of Education: MHRD under the scheme of Pandit Madan Mohan Malaviya National Mission on Teachers and Teaching have recently sanctioned a grant of Rs. 7.5 Crores as Non-recurring expenditure on account of infrastructure development during 2016-17.
- (iv) Kendriya Vidyalya: Land of 5 Acres has been earmarked for the establishment of KV. The Cost for the construction of KV Building in CUJ campus as per CPWD, PAR of 01.10.2012 on the basis of the Plinth Area has been worked out to Rs. 1613.66 Lakhs. The Building Committee in its meeting held on 12.12.2016 approved the estimates for above works and recommended the same to the Finance Committee for approval. Finance committee approved the same vide its meeting held on 06.01.2017 The same has further been approved in 12th Executive Council meeting held on 07.04.2017.

Chancellor, in view of the suggestions and observations of the members regarding various proposed new courses, advised the VC to undertake a critical analysis of the courses already being taught in the neighbouring universities in the J&K State and also the emerging trends vis-a-vis employment opportunities in the job market at home and at the national and global levels.

VC stated that a 2-3 day meeting of subject experts from institutions and members of the Court in the related areas would be organised in July 2015 to evolve definitive approaches regarding the nature and level of courses to be started w.e.f. Academic Session 2016-17.

The issue was deliberated in the meeting of Academic Council and introduction of new courses in the Session 2016-17 was done in the light of the discussions held with the experts invited from ISRO, DRDO, Aligarh Muslim University, university of Jammu and Industry experts.

A meeting of subject experts was convened by the Vice Chancellor in the presence of the two court members viz. Prof. K.L. Chopra and Prof. H.S. Sehgal.

Section 30(1) of the Central Universities Act, 2009, provides that the Annual Report of the University shall be prepared under the direction of the Executive Council, which shall include, among other matters, the steps taken by the University towards the fulfillment of its objectives and shall be submitted to the Court on or before, such date as may be prescribed by the Statute and the Court shall consider the report in its Annual Meeting. According to Section 30(2), the Court shall submit the Annual Report to the Visitor, along with its comments, if any.

Further, as per Section 30(3) of the Act, the Annual Report shall also be submitted to the Central Government, which shall, as soon as may be, cause the same to be laid before both the Houses of Parliament.

The Annual Report for the year 2014-15 and 2015-16, as prepared was placed before the Executive Council of the University in its meetings held on 09.11.2015 and 15.07.2016, respectively. Copies of the Annual Report, as approved by the Executive Council, have already been submitted to the Ministry of Human Resource Development, Govt. of India, within the prescribed time, for laying before both Houses of Parliament.

Section 20(2)(b) of the Central Universities Act, 2009, *inter alia*, provides for the Court to consider and pass a resolution on the Annual Report of the University.

The Annual Report for the year 2014-15 and 2015-16 are placed before the Court for consideration as separate books (02 in nos.).

To consider Annual Accounts, along with Separate Audit Report, for the Financial Year 2014-15 & 2015-16.

Section 31(1) and (2) of the Central Universities Act, 2009 provides that the Annual Accounts and Balance Sheet of the University shall be prepared under the directions of the Executive Council and shall be audited by the Comptroller and Auditor General (CAG) of India, at least once every year, and at intervals of not more than fifteen months.

A copy of the Annual Accounts, together with the Audit Report, thereon, shall be submitted to the Court and the Visitor, along with the observations of the Executive Council.

Accordingly, the Annual Accounts of the University for the period 1st April, 2014 to 31st March, 2015 and 1st April, 2015 to 31st March, 2016 were compiled in accordance with principles and procedures laid down by Ministry of Human Resource Development, Department of Higher Education, Govt. of India, and as per the guidelines of the UGC. These Accounts were prepared on accrual basis. The compiled Annual Accounts were considered and approved by the Finance Committee (on 29.06.2015 & 12.06.2016, respectively) and the Executive Council (on 09.11.2015 & 15.07.2016, respectively), before submission to CAG for audit.

The CAG Audit party completed the audit of these Accounts and the Principal Director (Audit), Chandigarh, on behalf of CAG issued the Separate Audit Report (SAR) for the year 2014-15, vide letter No. PDA(C)/CE/SARs/2015-16/264 dt. 03.12.2015 and for the year 2015-16 vide letter No. PDA(C)/CE/SARsCUJ-2015-16/2016-17/1090 dt. 28.10.2016.

The Annual Accounts, along with SAR for the year 2014-15 and 2015-16, as recommended by the Finance Committee (on 05.02.16 and 06.01.2017, respectively) were approved by the Executive Council in its 12th meeting held on 07.04.2017.

Copies of the Annual Accounts for these years along with SAR, as approved by the Executive Council, have been submitted to the Ministry of Human Resource Development, Government of India, for laying before both Houses of Parliament in terms of Section 31(4) of the Act.

Section 20(2)(b) of the Act, *inter-alia*, provides for the Court to consider and pass resolution on the Annual Accounts of the University and the Audit Report on such accounts.

The Annual Accounts, along with Separate Audit Report for the year 2014-15 and 2015-16, are placed before the Court for consideration, as **separate books** (02 in nos.).

To consider the Revised Estimates for the Year 2016-17 and Budget Estimates for the year 2017-18 and proposed estimates for next plan period.

The Revised Estimates for the year 2016-17 were based on expected flow of funds for expenditure under revenue and capital items. During the year 2016-17, the University established fifteen P.G. programmes, eight regular Integrated M.Phil/Ph.D programmes, four integrated M.Sc. Programmes, ten direct Ph.D programmes, two part-time Ph.D programmes, two Research Centres and two Certificate Courses. The increase in capital and revenue expenditure was attributed to academic and construction activities at site.

The University had an unspent balance of Rs.8682.17 lakhs as on 01st April, 2016 which was taken as the opening balance for the financial year 2016-17.

The demand projected for the year 2016-17 was initially estimated to be Rs. 51000.00 lakhs which has now been revised to Rs.31000.00 lakhs with the revised estimated expenditure of Rs.27841.45 lakhs. Based on this flow of expenditure and expected activities, the University proposed grant of Rs.38000.00 lakhs during the year 2017-18. Taking into account the proposed grant of Rs.38000.00 lakhs, the University shall be having following funds available for 2017-18 subject to release of funds to the extent of Rs. 31000.00 lakhs during 2016-17.

Out of this, expenditure is estimated to be Rs.40997.65 lakhs as per details given in the Annexure. Therefore, funds to the extent of Rs.38000.00 lakhs have been proposed as Grant-in-aid from UGC for the year 2017-18. If funds are available as projected above, the University shall be left with a balance of Rs.11315.17 lakhs at the end of the year 2017-18 which may cater to the requirements for one or two months of the subsequent year for administrative expenses and part development including clearing of immediate liabilities.

The Budget Estimates are based on the expected construction activities already initiated and planned to be started in coming financial year 2017-18 and other recurring expenses, including salaries. The proposed expenditure on some identified activities including the construction work has also been tentatively worked out at Rs.875.00 crores for the next plan period of five years. Though the estimated receipt for the next years have not been contemplated, the University may have to ask for the required funds annually.

The Revised Estimates for the year 2016-17 and The Budget Estimates for the year 2017-18 were discussed in the meeting of the Finance Committee held on 6th January, 2017. The Finance Committee resolved to approve the item and recommended the same for consideration of the Executive Council.

The Executive Council in its 12th meeting held on 7th April, 2017 approved the recommendations of the Finance Committee.

The Revised Estimates for the year 2016-17 and Budget Estimates for the year 2017-18 are placed before the Court for consideration as **Annexure-A**, page no. 49-.

NOTES

1. The Expenditure on seminars and conferences has been worked out on the assumption that for 21 existing departments there shall be one National Seminar each year and one International Seminar every three years but there shall be no national seminar during the year when an international seminar is held. Thus over a period of five years there shall be four national and one international seminar for each department. It is understood that maximum ceiling of expenditure is as follows:

National Seminar Rs.7.00 Lakhs each seminar

International Seminar Rs.15.00 Lakhs each seminar

Thus each department may require Rs.43.00 Lakhs for all the five seminars over a period of five years. This will mean expenditure of Rs.900 Lakhs for 21 existing departments.

Based on the assumption that each of the existing department shall be allowed one Research Project annually there will be 21 Research projects each year or 105 for the Five year plan period.

There shall be an estimated provision of Rs.5.00 Lakhs for each Science department for each project and having 5 Science department will mean provision of Rs.125 Lakhs while Rs.240 Lakhs for Non Science departments making a total of Rs.365 Lakhs on this account.
