Item No.1 To consider Report of the Vice Chancellor about the development activities since inception of the University.

• The Central University of Jammu was established and incorporated by the Central Universities Act, 2009(Act No. 25 of 2009) read with the Central Universities (Amendment) Act, 2009(Act No. 38 of 2009), with effect from October 20, 2009, having its territorial jurisdiction extending over the Jammu Division of the State of Jammu and Kashmir. Dr. Sudhir S. Bloeria assumed the charge as its founder Vice-Chancellor on August 08, 2011 and on that day the Central University of Jammu actually came into being.

Administrative Office and Temporary Academic Block TAB-I

- The University Administrative office started functioning from 37 C/C, Gandhi Nagar,
 Jammu, in a building hired by the erstwhile Central University of Jammu and Kashmir
 as it's Jammu Camp Office in July, 2009. The Administrative Office was adequately
 furnished and facilities like computer networking, furniture, furnishings and office
 equipment were put in place.
- A building was hired for establishment of Temporary Academic Block (TAB-I) in the month of September, 2011 to meet the requirements of adequate space for faculty, students and staff.
- The TAB-I, located at Narwal Sidhra Bye-Pass Road, was made fully functional by equipping with modern furniture, library and setting up a computer lab with seamless Wi-Fi Internet connectivity along with facility of auditorium, play field and cafeteria as support systems for the students.

Academic Activities/Other Initiatives

 By the time the Central University of Jammu assumed its functioning, the academic session had already begun in almost all the other universities. Therefore, the CUJ was left with two alternatives, either to start the academic session 2011-12 a bit late and fill up the time gap in the next two years, or to wait for one year and to begin the academic session in time next year. The University decided to go for the first option inspite of the limited facilities in the form of resources, space and infrastructure and a bare skeleton staff appointed on contract/deputation basis.

- A meeting with the Vice Chancellor and Deans of various Faculties of the University
 of Jammu was held on August 16, 2011 to deliberate upon various academic
 initiatives required to be undertaken. After deliberation a consensus emerged that
 the CUJ should focus on complimenting and diversifying the academic activities
 keeping in view the academic programmes already being pursued by the University
 of Jammu.
- After initiating consultative process with academic fraternity, the University decided
 to start three academic programmes at the initial stage i.e. Master's Degree
 Programmes in Applied Mathematics, Economics and English & Comparative
 Literature with intake capacity of 30 students in each programme.
- Expert Committee meetings in the respective subjects were held to frame the scheme of courses and the syllabi for adoption.
- Notice for admission inviting applications for Master's Degree programmes was
 issued on August 27, 2011 in National and Local dailies. 192 candidates applied for
 the three programmes. A total of 64 students were enrolled for the academic session
 2011-12.
- Faculty Recruitment was made on contract basis after advertisement of posts and interviews held by a Committee headed by the Vice Chancellor, comprising three outside experts.
 - Six Assistant Professors (two in each subject) were appointed.
 - Three professors (Retd.), one each in the subjects of Economics, English and
 Mathematics were engaged on contract basis for a period of one year.
 - Academic Programmes were also supported and enriched by the visiting faculty from various Universities /Institutions.
- Website of the Central University of Jammu "www.cujammu.ac.in" was hosted on September 26, 2011 with declaration of the first select list for admission of students.

- Induction programme for the first batch of students was held on October 10, 2011.
- The University also introduced M. Phil. Programme in English. Admissions to this
 programme were made through an Entrance Test held on November 12, 2011,
 conducted in collaboration with Central University of Himachal, and class work was
 started from January 5, 2012.
- An Academic Committee, comprising three eminent Professors of Jammu University,
 who had superannuated, was constituted to frame the guidelines, draft rules/
 statutes/ordinances/regulations and for accomplishment of admissions to the
 academic programmes to be started during the academic session 2011-12; as also to
 advise the Vice-Chancellor on academic matters.
- Framed 24 drafts Statutes, Ordinances and Regulations as also prepared drafts for establishment of Schools and Departments.
- Vice-Chancellor along with senior officers of the University visited Central University
 of Tamil Nadu, Pondicherry Central University, Central University of Rajasthan, NIIT
 University, Neemrana to study the pattern of overall developments, courses offered,
 systems and innovations adopted as well as construction activities undertaken by
 them.

Keeping in view the requirement for more commodious place for administrative office and academic space to cater to the introduction of new academic programmes and envisaged increased functions of the University, the new administrative office located at 8/8, Trikuta Nagar, Jammu was operationalised on January 01, 2012.

After initiation of Academic Session 2011-12 with introduction of Academic Programmes, Rolling Down the admission process, Framing of Course Structures and Syllabi, Statutes and Ordinances, Establishment of Academic Block and putting in place the Students' Central Facilities and Development of Infrastructure, Recruitment of Faculty; by March 2012, the efforts were afoot to prepare for the Academic Session 2012-13. In view of the proposed introduction of eleven new

academic programmes all the initiatives were chanellized to put in place infrastructural requirements. In the meantime the first Executive Council and the first Academic Council were also constituted vide letter No. 52-6/2011- Desk (U) dated: 19th March, 2012 by Ministry of Human Resource Development, Department of Higher Education, Government of India, New Delhi. The first meetings of the Academic Council and that of the Executive Council were held on 25.04.2012 and 04.05.2012 respectively.

The first meeting of Finance Committee was held on 12th June, 2012, after its constitution with the Nominees of the Visitor and the Executive Council.

Comprehensive review to the various activities undertaken by the University from Academic Session 2012-13 is being provided for perusal of worthy members.

Admissions

The University proposed admission for fourteen Post-Graduate Programmes in the subjects of Economics, International Relations, Public Policy and Public Administration, Defence and Strategic Studies, Philosophy, Communication Management and Advertising, Social Work, Master of Education, Computer Sciences, Environmental Sciences, Applied Mathematics, English & Comparative Literature, MBA Tourism and Travel Management and MBA Human Resource Management and 06 Research Degree Programmes in Economics, Mathematics, International Relations, Education, Public Policy and Public Administration and Tourism & Travel Management for the Academic Session 2012-13. Admission process started from 10th of April, 2012. Admission to these programmes was made through Central Universities Common Entrance Test (CUCET) conducted by the Collegium of seven Central Universities at All India Level. Applications were invited in both online and offline modes. 17th May, 2012 was the last date for submission of application forms by the candidates. The test was conducted on June 3rd, 9th & 10th , 2012 in offline and online modes. Total 2893 candidates applied and 2072 appeared for the advertised programmes of the CUJ in Post-Graduate & Research programmes.

Six programmes namely M.A. International Relations, M.A. Public Policy and Public Administration, M.A. Defence and Strategic Studies, M.A. Philosophy, M.A. Communication Management & Advertising and M.A. Social Work were not started by the University in view of the inadequate response. 214 students were admitted in the eight Programmes of Studies started by the University in the First Semester as against the total seats of 270 at Post-Graduate level. As against 04 Integrated M.Phil.-Ph.D. Programmes started by the University with total of 20 seats available, only 13 students got enrolled. Integrated M.Phil.-Ph.D. could not be started in Tourism and Travel Management.

Results

- A major achievement during the month of July, 2012, was the successful completion
 of the first year (two semesters) of P.G. Programmes the result of which was
 declared on 27th of July, 2012.
- The result of first semester of M.Phil. (English) was declared on 5th September, 2012.

Workshops for formulation of Scheme and courses of studies

Seven Workshops were organised with Experts participants from different universities in the country in the concerned subjects, namely, MBA (Tourism and Travel), Communication Management and Advertising, Master of Education (M.Ed), M.Sc. Environmental Sciences, M.Sc. Computer Science, MBA (Human Resource Management), and Studies of Chinese Language, for preparing the scheme of courses and prescribing the syllabi, for the proposed PG Programmes during 2012-2013.

Contractual Faculty Recruitment

In order to strengthen the Departments, interviews were held for various faculty
positions on contractual basis, in the subjects of Education, Environmental Sciences,
MBA (Tourism and Travel Management), MBA(Human Resource Management) and
 Computer Sciences during the month of July, 2012.

Selection Committees for appointment of faculty on contractual basis in the subjects
of English and Comparative Literature, Mathematics and Economics were held
during the month of August, 2012. These temporary measures were necessitated
due to delay in getting mandatory sanctions. Presently the University has six
Teaching Assistants, twenty two Assistant Professors and six Professors.

Establishment and Infrastructure Development at TAB-II

With the announcement of admission process for the academic session 2012-13 the University initiated the process for identifying a suitable location and adequate infrastructure for establishing the Temporary Academic Block II in order to start the new Post-Graduate and Research Degree Programmes. A building adequately commodious was hired to house Teaching Departments having an adjoining area of 24 Kanals located at Sainik Colony Extension, Jammu.

Since the academic session was to start from August, 2012, virtually starting from scratch, University pooled all its resources for development of infrastructure necessary for Campus functioning and the same was put in place in record time of two months. Established 14 class rooms, faculty rooms for H.O.D.s and Assistant Professors/Teaching Assistant (about 30), 3 computer labs, aesthetically designed Cafeteria, spacious Library, separate Common Rooms for boys and girls with sports facilities, Auditorium having capacity of 165 persons with green room, Committee Room accommodating about 25 persons for small group discussions and deliberations and MI Room for medical check up by Doctor appointed by the University. The Campus is networked in its entirety and is having Internet Facility both wired and wireless so as to share the data and resources. Request has been made to BSNL and NIC to bring the campus on NKN project. Optical fibre has been laid down and NKN facility is expected to be available soon. Two hostels one for boys and one for girls have also been established by the University from the academic session 2012-13.

In view of the University having two separate academic Blocks, out of the eight departments for which the students were admitted, after having consultative process with Departmental Incharges, two departments (Education and English) are currently housed in Temporary Academic Block-I and rest six departments

(Economics, Computer Sciences, Environmental Sciences, Mathematics, MBA Tourism and Travel Management and MBA Human Resource Management) were started in Temporary Academic Block II.

Regular Faculty Recruitment

The University had issued advertisement for appointment of faculty positions vide No.CUJ/Aptt/2011-12/Advt(2)/811 dated 3rd March, 2012 in the proposed subjects to be started during Academic Session 2012-13 in anticipation of approval of posts by the University Grants Commission.

Approval of faculty positions was conveyed by the UGC in August, 2012 as also details of nominees of the Visitor for various Selection Committees were received from MHRD during August only.

Advertisement notice for regular faculty recruitment was issued on 13.02.2013 and last date for receipt of application forms was 15-03-2013. Applications received in response to the advertisement are being processed and Selection Committee meetings are proposed to be held in the month of May and June, 2013.

An advertisement notice for making permanent appointment to the posts of Registrar, Finance Officer, Deputy Registrar, Deputy Librarian, Assistant Registrar and Assistant Librarian was issued on 12-10-2012 with last date for receipt of applications as 15.11.2012. Interview for the post of Registrar was held on 15.02.2013. The post has been readvertised in view of the recommendation of the Selection Committee. The post of Finance Officer has also been re-advertised due to inadequate response of the eligible candidates. The last date for receipt of these applications is 22nd April, 2013. The interviews for the said posts will be held in the month of May, 2013 after soliciting the convenience of nominees of the visitor.

- Appointment of Visitor Nominees on Selection Committees for teaching posts conveyed vide Order No. 52-2/2012-Desk(U) dated 27th August, 2012.

Support from University Grants Commission:

- During the year 2011-12, UGC sanctioned Rs.1150 lacs under General Development Scheme out of which utilization certificate to the tune of Rs.337.18 lacs upto 31st March, 2012 was furnished. Subsequently, UGC allocated Rs.3000 lacs under General Development Scheme. Rs.100 lacs under Merged Scheme and Rs.20 lacs under Fellowships Schemes to Non-NET. M.Phil.-Ph.D. Scholars for the year 2012-13, out of which Rs.750 lacs, Rs.25 lacs and 12.50 lacs respectively were released upto August 3rd, 2012 and Rs. 2250 lacs released on March 7th, 2013.
- UGC conveyed approval of one hundred and forty faculty positions including twenty one positions already sanctioned for the three teaching departments vide letter No. F.40-1/2011(CU) dated 3rd August 2012.
- Sanction of 16 posts of Support Staff on regular/short-term contract was also received during the year 2012 vide letter No. F.40-1/2011(CU) dated in 6th September, 2012. Another sanction of 20 positions was accorded by UGC vide letter no. F.40-1/2011(CU) dated 14th March, 2013.

Important Events

- Hon'ble President of India in his capacity as Visitor of the Central University of Jammu has appointed Sh. N.N. Vohra, Hon'ble Governor J&K, as the first Chancellor of the University for a period of five years.
- Constitution of First Court of the Central University of Jammu vide MHRD Order No.52-3/2012-Dest(U) dated 11th October, 2012.

- Meeting of Vice Chancellors of all Universities located in J&K with Hon'ble President
 of India was attended by the Vice Chancellor of Central University of Jammu at Raj
 Bhavan, Srinagar on 27th September, 2012.
- Vice Chancellor conference of Central Universities convened by the Visitor, Hon'ble
 President of India, held on 5th of February, 2013 at Rashtrapati Bhawan, New Delhi, was attended by the Vice Chancellor, Dr. S. S. Bloeria.

Significant steps undertaken

- Constituted Boards of Studies and Boards of Research Studies in the various subjects and Schools respectively established by the University to strengthen the academic programmes at the Department and School levels.
- Vice Chancellor participated in a meeting held at New Delhi for conduct of Central
 Universities Common Entrance Test (CUCET) for Academic Session 2013-2014
 wherein Vice Chancellors of other interested Central Universities were also invited.
 The Central University of Jammu was one of the seven participating members of the
 CUCET group last year also. This year three new members have joined the initiative.
- First meeting of the Standing Committee for the Academic Council was held on 26-12-2012.
- Dr. P.S. Pathania, OSD (Administration), attended rhe meeting of the Registrars of CUCET Collegium of Universities to finalize schedule for admission of the academic session 2013-14 on 7th January, 2013-14.
- First meeting of the University Building Committee was held on January 03, 2013 wherein presentations by the competing Public Sector undertakings for PMC was made. A Building Sub-Committee was constituted to provide technical inputs to the University to take decisions in the Campus development and other temporary infrastructural needs for the smooth functioning of the academic activities.

Based on the technical bids of the participating Public Sector Undertakings for PMC, first three competitors were finalized and financial bids of the three were opened in

a meeting of the University Building Committee held on January 10, 2013. Details of the competition for technical and financial bids in term of tender documents for PMC were compiled.

- A meeting of the experts to discuss the contours for the establishment of department of National Security Studies comprising Dr. S.S. Bloeria (Vice Chancellor), Air Cmde Jasjit Singh(DG CAPS, New Delhi) and Prof. Gopal Ji Malviya from University of Chennai was held on 13th January, 2013 at India International Centre, New Delhi.
- Finalized the sixteen Ordinances and three Regulations governing Academic and Administrative matters. After approval by Executive Council in its meeting held on January 14, 2013 the Ordinances and Regulations have been submitted to MHRD, Govt. of India for further action.
- Selection of Architect for the Central University has been made after following the necessary process. First phase of Architectural Competition was held on 5th and 6th October, 2012 in EdCIL House New Delhi. Out of ten entries, four were shortlisted, based upon the general layout and concepts of the proposed Master Plan of the Campus.

Second phase of the competition among the four short listed Architects was held on 12-01-2013 at IIC, New Delhi, who made presentation before the jury comprising four experts, two Executive Council members and Vice Chancellor, CUJ. The financial bids of the first two selected Architects based on technical inputs and presentations were opened. Based on the tabulated data of technical score and financial bids score the first and second Architects were finalized. The competition was organized by the EdCIL, Delhi.

- The Finance Committee meeting was held on 14th of January, 2013, at 10am India International Centre New Delhi.
- Meeting of the Executive Council was held on 14th of January, 2013, at 2pm India International Centre New Delhi. Apart from other items on the Agenda, the Finance Committee and the Executive Council approved the selection and appointment of the Architect and PMC for the Central University of Jammu. The assignment of the

Architecture and Master Plan has been awarded to Sikka Associates Architects, New Delhi and Engineering Project India Limited (EPIL) New Delhi respectively.

- A High Level Hindi Committee of MHRD held it's meeting on January 24, 2013 which
 reviewed and appreciated the initiatives taken by the CUJ in giving Hindi a due place
 in its scheme of things. It was also decided that 'three posts of Hindi Officers and
 Typist etc. recently sanctioned by the UGC be advertised and recruitment made
 against these posts at an early date.
- Conceptual drawings and models of all the four short-listed entries for the final
 phase of the architectural competition were displayed at Kala Kendra Jammu for
 viewing by the general public from January 27 to January 31, 2013. Hon'ble
 Governor, J&K, Shri N.N. Vohra, Chancellor of the University, visited Kala Kendra to
 see the models and drawings and appreciated the efforts made by the University in
 selection of Architect. Prominent amongst other visitors, were Hon'ble Forest
 Minister, J&K Mian Altaf, Major General (Retired) Jagdish Singh Jamwal and Hon'ble
 MLA, Shri Surjeet Singh Salathia of Vijaypur Constituency (Samba).
- A meeting to discuss the budget estimates of 2013-14 and revised estimates of 2012-13 held on 1st March, 2013 at UGC was attended by Dr. P. S. Pathania, OSD (Administration) and Sh. H. K. Prashar, OSD (Finance).
- Dr. S.S. Bloeria visited University of Rajasthan Jaipur, to discuss and study the model adopted and best practices of the Department of Public Administration on 4th March, 2013.
- Results of the 1st and 3rd semester examinations held in January, 2013 were declared on 28th February, 2013 and 19th March, 2013 respectively.

Highlights of the Functions Organised:

 Academic session 2012-13 of the Central University of Jammu started with an Induction Programme held on 8th August, 2012. The Vice Chancellor welcomed the students of first semester of the eight Post-Graduate programmes and emphasised the value of laying ethical foundations by the students of third semester, for the newcomers to follow. While celebrating the Induction day, the first Issue of News Letter of the University "Campus Update" was released by the Vice Chancellor.

- On the Independence Day, flag hoisting ceremony was performed at both Academic Blocks as well as in the Administrative Block with enthusiastic participation of the faculty, students and the staff.
- Foundation Day was celebrated on 10th October, 2012. It has been decided that from the session 2013-14 onwards, Foundation Day of the Central University of Jammu shall be celebrated on 8th August and 10th of October will be observed as "Old Students Day".
- Faculty and students of the CUJ visited the proposed Campus site on 8th November,
 2012, for a picnic cum familiarization trip.
- On the Republic Day, the flag hoisting ceremony was performed at the Academic Blocks as also in the Administrative Block with the full participation of the faculty, students and the staff. Vice Chancellor, Dr. S.S. Bloeria unfurled the flag at Academic Block-II.
- Cultural event under the aegis of SPICMACY was organized on 28th of January by Kala Ramanathan (a Violinist of International repute) in TAB-I, wherein apart from faculty, students of the Central Universities, students of neighbouring schools also participated.
- Organised cultural programme under aegis of Sa Ma Pa Alap where Sarangi Recital and Sufiyana Folk Songs were performed on 13th of February, 2013 at TAB-II.
- A cultural festival of the Central University named "Udaan" was organized on 20th and 21st of March, 2013 wherein students participated in the competition of Photography, Rangoli, Painting, Collage making, Fancy dress, Poetry Recitation and Vocal Solo events.

Status Report regarding Transfer / acquisition of land to/for the Central University of Jammu as on 24-03-13

For establishing the Central University of Jammu, the State Government has allocated two chunks of land falling on northern and southern sides of the Raya Morh – Mandal Road. The quantum of land comes to 4880 kls 19 mls(610 Acres). The land is situated at Village Bagla, District Samba and as per revenue records, further description of the same is as under:-

State land

: 4254 kls 14 mls

Private land

: 584 kls 06 mls

Evacuee's land

: 41 kis 19 mls

The status of transfer /acquisition of land to/for the University is as under:-

Transfer of 3000 Kanals of Forest land :

The land measuring 3000 Kanals of State land, which the Forest Department had claimed to be Forest land, has been handed over by the Forest Department to the Higher Education Department. The matter stands taken up with the Higher Education Department for initiating further process for entering into MOU/lease Agreement and transfer of the said land to the Central University of Jammu.

Transfer of State land measuring 1254 Kanals 14 Marlas:

As per a decision taken in a meeting held under the Chairmanship of Principal Secretary, Planning & Development J&K Government, the land in question has been held to be State land. But in view of existence of a number of trees/bushes over the said land it has been decided to seek permission for cutting down trees/removal of bushes after payment of compensation by the Higher Education Department as would be decided by the Forest Advisory Committee headed by the Chief Secretary. The Secretary to Govt. Higher Education Department has accordingly taken up the matter with the Forest Department. In turn, Forest Department in association with State Higher Education Department has, after conducting enumeration of trees and assessment of compensation etc, compilation of requisite details/ documents, taken up the matter with Forest Clearance Committee. After lot of follow up, the issue was put on the agenda of the said Committee in its last meeting held on 08-03-2013. Although the Committee has cleared the case, but minutes of the meeting have not been issued yet.

Acquisition of private and evacuee's land measuring 626 Kanals 5 Marlas:

The Collector Land Acquisition Samba has announced the final award. As per final award there has been a shortfall of an amount of Rs. 67.045 lac over and above the amount of Rs. 384.99 lac already placed at the disposal of DC Samba for this purpose on account of compensation to be paid the ex-owners. The matter has been taken up with Higher Education Department for release of the additional requirement. After the amount is released, land will be got handed over to the Higher Education Department for further leasing out and handing over the same to the Central University of Jammu.

Campus developmental activities at proposed site of Central University of Jammu.

In order to undertake the development of the requisite infrastructure needs within the campus, the University engaged M/s EdCIL Limited (A Govt. of India- Public Sector Undertaking) for working on three pronged activities, as detailed under:

- Preparation of the Site Plan and the Contour Survey of the entire area.
- Preparation of the document for inviting Architecture Design Competition for the lay out plan and facilitate the adjudication of the same.
- Preparation of Master Plan of the entire area of the Central University of Jammu.

Work on the Site Plan and Contour Survey of the area has been accomplished and Master Plan of the entire area has been finalized.

Based on the recommendations of the Finance Committee and approved by the Executive Council at its meetings held at 10am and 2pm on 14th of January, 2013 respectively, M/S Sikka Associates Architects New Delhi has been appointed Architect and Engineering Projects India Ltd.(EPIL) New Delhi has been approved as Project Management Consultants for the development of Campus of Central University of Jammu at village Bagla, district Samba.

Demarcation of the proposed site has been completed. Further in order to avoid any encroachment and future litigation, pillars on the demarcated land have been fixed, and security guards posted.

A site office has also been put in place by the University in order to facilitate close supervision and for on the site deliberations by all the stake holders engaged in development pursuit of the Campus.

The State Government has been requested to provide;

- A wide four-lane approach road to the Campus by way of widening and improving the 6 km stretch of existing village road, from the National Highway NHIA.
- A captive Receiving Station of 2x6.3 MVA capacity.
- Dependable source of water sufficient to cater to the optimum need of the Campus.

Thus through a judicious combination of forceful exertions and imaginative use of resources available, the Central University of Jammu was able to initiate academic activities within two months of its coming into existence in August, 2011. The next year, 2012, has been a period of expansion with the launching of nine Post Graduate and Research programmes. The current year is designated to be a period of consolidation, with only four new Research programmes slated to be added to the existing bouquet of academic endeavours. As per the current indications, the construction activities on the Campus are likely to commence within next four to six months and with that, the contours of the CUJ would start emerging.

Item No.2: To Consider Annual Report for the year 2011-12.

Section 30(1) of the Central Universities Act 2009 provides that the Annual Report of the University shall be prepared under the directions of the Executive Council which shall include among other matters, the steps taken by the University towards the fulfilment of its objects and shall be submitted to the Court on or before such date as may be prescribed by the Statute and the Court shall consider the report in its Annual Meeting.

As per section 30(3) of the Act the Annual Report shall also be submitted to the Central government, which shall, as soon as may be, cause the same to be laid before both the Houses of Parliament. Since the meeting of the Executive Council could not be held for want of receipt of Separate Audit Report from the CAG's office, and the Ministry of Human Resource Development was pressing very hard to meet the deadline of placing Annual Report before the Parliament, the Vice Chancellor authorised submission of the Annual Report to the Ministry of Human Resource Development, in anticipation of approval of the competent authority, on 10th December, 2012. Action taken by the Vice Chancellor in this respect was confirmed by the Executive Council vide item No. 5 in its meeting held on 14.1.2013.

Section 20 (2) (b) of the Act inter alia, provides the Court to consider and pass resolutions on the Annual Report of the University.

The Annual Report is placed before the Court as Annexure I for consideration.

Item No.3: To consider the Annual Accounts along with Audit Report for the year 2011-2012.

Section 31 (1) and (2) of the Central Universities Act, 2009 provides that the Annual Accounts and Balance Sheet of the University shall be prepared under the directions of the Executive Council and shall once at least every year and at intervals of not more than fifteen months, be audited by the Comptroller and Auditor General of India or by such persons as he may authorise in this behalf. A copy of the Annual Accounts together with the Audit Report thereon shall be submitted to the Court and visitor along with the observations of the Executive Council.

Annual Accounts along with Audit Report of the University for the year 2011-12 duly considered and recommended by the Finance Committee vide item No. 4 in its meeting held on 14.01.2013 at 10.00 AM was placed before the Executive Council in its 2nd meeting held on 14.01.2013 at 2:00 PM. After approval by the Executive Council vide item No. 13, the Annual Accounts along with Audit Report have been submitted to the Department of Higher Education, Ministry of Human Resource Development, Govt. of India, New Delhi to be laid before the Parliament.

Section 20 (2) (b) of the Central Universities Act 2009 inter alia provides the Court to consider and pass resolution on the Annual Accounts of the University and the Audit Report on such accounts. The same are placed before the Court for its consideration as Annexure- II.

Item No.4: To consider Budget Estimates for the year 2013-14 and Revised Estimates for the year 2012-13.

The Central Universities Act, 2009, statute 10 (2) provides that at an annual meeting of the Court, a report on the working of the University during the previous year, together with a statement of the receipts and expenditure, the balance sheet as audited, and the financial estimates for the next year shall be presented.

The Central University of Jammu started its functioning with effect from 8th August, 2011. A lumpsum amount of Rs.1150 lac was sanctioned as Grant-in-Aid and Rs. 18.37 lac was internal receipt during the year 2011-12 out of which expenditure of Rs. 335.08 lac was made and Rs. 833.29 lac remain unspent upto 31st March, 2012 which was taken as opening balance for the year 2012-13. Executive Council of the University was constituted subsequently on 19th March, 2012. First meeting of Executive Council was held on 04.05.2012. The Finance Committee was constituted after obtaining the names of three nominees of the Executive Council. First meeting of the Finance Committee was held on 12.06.2012 which considered the Accounts vide item No. 23 and recommended for approval of Executive Council. Approval of the Accounts was obtained from members of the Executive Council by circulation. Audit of the Accounts was taken up in the month of June. SAR along with Annual Accounts has been approved by the Executive Council and has been placed before the Court at item No. 3 for consideration.

The Budget Estimates for the year 2013-14 and Revised Estimates for the year 2012-13 duly considered and recommended by the Finance Committee vide item No. 5 in its meeting held on 14.01.2013 at 10.00 AM, were considered by the Executive Council in its meeting held on the same day at 2:00PM which approved the recommendations of the Finance Committee vide item No. 13. Budget Estimates for the year 2013-14 have been proposed to the tune of Rs. 21927.66 lac and Revised Estimates for Rs. 3120 lac for the year 2012-13 and have been submitted to the University Grants Commission for further necessary action. Out of the revised estimates UGC has so far released 3037.50 lac during the current financial year 2012-13, Rs. 3000 lac under General Development Schemes, Rs. 25 lac under Merged Schemes and Rs. 12.50 lac under Non-NET, M.Phil./Ph.D. fellowship. The Budget Estimates and Revised Estimates are placed before the Court for perusal as Annexure-III.

Item No.5 To consider nomination of a person to the Finance Committee of the University.

The Central Universities Act, 2009, statute 17 (1) provides for constitution of the Finance Committee which consists of the following members:

- i. The Vice Chancellor;
- ii. The Pro-Vice Chancellor;
- iii. One person to be nominated by the Court;
- iv. Three persons to be nominated by the Executive Council, out of whom at least one shall be a member of the Executive Council; and
- v. Three persons to be nominated by the Visitor.

The matter is submitted for consideration of the Court and for nomination of one person to the Finance Committee in pursuance to clause iii above.

Item No.6. To consider fixation of date for the next meeting of the Court.

The Central Universities Act 2009, Statute 10 (i) provides that an Annual meeting of the Court shall be held on a date to be fixed by the Executive Council unless some other date has been fixed by the Court in respect of any year.

The matter is submitted for consideration of the Court.

Establishment of the University

The Central University of Jammu has been established by the Central Universities Act, 2009 (Act No. 25 of 2009) read with the Central Universities (Amendment) Act, 2009. However, the Central University of Jammu actually came into being on August 08, 2011, with the joining of its first Vice-Chancellor, Dr. S.S. Bloeria.

Reports

Appointments

With the establishment of the University the following were appointed:

- (a) Officer on Special Duty (Administration)
 - Services of Dr. P.S. Pathania, Registrar, University of Jammu, were sought on deputation from University of Jammu. With his induction on 10th August, 2011 the Administration Office became functional.
- (b) Officer on Special Duty (Finance) Services of Sh. H. K. Prasher, Financial Advisor and Chief Account Officer of Department of Higher Education were sought on deputation from J&K State Government with his joining on 15th September, 2011 the Accounts Section of the University became functional.
- (c) Consultants

In order to formalise the acquisition of land and development of infrastructure thereon the following consultants were appointed:

Sh. K. K. Gupta, Former Chief Executive Officer, Patnitop Development Authority, Government of J&K, an accomplished engineer of proven capabilities, as Consultant (Work).

Sh. V. K. Gupta, Former Special Secretary to Government of J&K, an eminent expert in land revenue matters as Consultant (Land Management).

(d) Academic Committee

An Academic Committee comprising three eminent Professors of University of Jammu viz.,

who had recently superannuated was constituted to frame guidelines, draft rules, statues, ordinances, regulations and for admission to the academic programmes envisaged for the academic session 2011-12 as well as to advise the Vice-Chancellor on academic matters.

Administrative Office

The University started functioning from its Administrative Block at 37 C/C, Gandhi Nagar, Jammu, in a building hired by the erstwhile Central University of Jammu and Kashmir as its Jammu Camp Office in July, 2009.

The administrative office was later shifted to a spacious hired building at 8/8, Trikuta Nagar, Jammu on January 01, 2012. The administrative office has been adequately furnished and facilities like computer networking, furniture, furnishings and office equipment were put in place.

Temporary Academic Block-I

Temporary Academic Block-I (TAB-I) located on Narwal-Sidhra Bye Pass Road, near Environmental Park, was hired and made fully functional during October 2011 to accommodate the three Teaching Departments- Department of English and Comparative Literature, Department of Applied Mathematics and Department of Economics. Facilities provided at TAB-I include Computer Laboratory with Wi-Fi Internet Connectivity, Library, Mini Auditorium, Play Field and Cafeteria etc.

Campus Site and its Development

- State Government has proposed to allocate 4880 Kanal 19 Marla (Approx. 600 Acres) of land comprising 3000 Kanal of forest land, 1254 Kanal 14 Marla State land, 584 Kanal 6 Marla private land and 41 Kanal 19 Marla of evacuee's land, for the establishment of Central University of Jammu at Village Bagla, District Samba, Jammu Division. The location is at a distance of 25 kms from Jammu City, the winter capital of Jammu and Kashmir State and 17 kms. from the District Headquarters of Samba. The nearest Railway Station and Airport are at a distance of 20 kms. and 25 kms. respectively.
- The State Government vide Government Order No. 340-FST of 2010 dated 27-08-2010, has accorded sanction to the diversion of 3000 Kanal of forest land for establishment of the Central University of Jammu.
- An amount of Rs. 14,085 Crore has been released as land compensation in favour of Forest Department by the Higher Education Department, J&K Government.
- State Higher Education Department has been requested to further release 2.11
 Crore on account of Compensatory aforestation to the Forest Department.
- Demarcation for possession of land earmarked for the Central University of Jammu has started and is being undertaken by a team comprising members from Revenue Department, Forest Department and representatives of the Central University of Jammu headed by Consultant (Land Management). The team is assisted by the Police and Administration of District Samba as and when needed.
- EdCIL (India) Limited, a Government of India Enterprise, has been contacted for preparation of the Master Plan for Central University of Jammu. The University






- has placed the job order for preparation of site plan, contour plan and also selection of an architect for preparation of detailed plan through All India Architecture Competition.
- Contour Survey of the site was started last month and is likely to be completed by May, 2012 and thereafter, the process of Architecture Competition will begin.
- To prevent any encroachment of the earmearked site, work for fixing of boundary pillars was undertaken and has already been completed, in most of the Campus Site boundary.
- Central Public Works Department has been entrusted with the job of preparing the estimates for construction of boundary walls of the proposed Campus.
- State Land measuring 1254 Kanal 14 Marla is under dispute for Title of the Land between the State Revenue Department and Forest Department. The matter has been taken up for resolution with higher authorities in the state government.
- Higher Education Department of the State Government has placed an indent
 with the Collector, Land Acquisition Samba for acquisition of the private land
 and the evacuee property falling within the proposed site measuring 584 Kanal 16
 Marla and 41 Kanal 19 Marla respectively. The State Government has also
 released funds for payment of compensation in connection with the
 acquisition of land. Matter is also being pursued vigorously by the University
 Authorities.

- UGC has conveyed its approval for 21 Faculty Positions (3 Professors, 6 Associate Professors and 12 Assistant Professors for three Academic Programmes i.e. M.A./M.Sc in Applied Mathematics, M.A. Economics and M.A. English and Comparative Literature vide letter No. F. 40-1/2011 (CU) dated November 11, 2011.
- Visitor's three nominees have been appointed on the Finance Committee of the Central University of Jammu during November, 2011.
- Visitor's nominees have been nominated for the appointment of first Registrar and first Finance Officer of the Central University of Jammu.





He was accompanied by Dr. P.S Pathania, OSD, Administration. He took a round of the Library, Computer Laboratory and the Departments of English, Economics and Mathematics. While interacting with the faculty and students, he commented on the advantages of the location of the

campus amidst the serene environment of the Sidhra valley. He congratulated the staff, faculty and students of the University for their achievement in such a short span of time.

Vice-Chancellor's Lecture at IIPA Jammu.

A Lecture was delivered by Dr. S. S. Bloeria, Vice-Chancellor Central University of Jammu at IIPA branch in Jammu on the development of a strategic partnership between India and Afghanistan in recent times. As a keen student of History, Dr. Bloeria analysed India's relations with Afghanistan. Prior to Independence India was indifferent to maintaining relations with Afghanistan, but after independence a change occurred. Dr. Bloeria attributed the change in policy towards Afghanistan to the superpower rivalry that erupted in 1978 in which Pakistan emerged as an important player by supporting Talibanis. India woke up to the fact that Afghanistan was important for India not only from the point of view of security but also from the economic perspective (in terms of providing an alternative source of energy - Afghanistan's vast mineral reserves). This resulted in changes in India's foreign policy. It supported Afghanistan's efforts in negating Talibanism and curbing drug trafficking in the region. Hence, after the collapse of the Taliban in 2001, India moved quickly in Afghanistan re-opening its consulates in north, south, west and east Afghanistan. It also made considerable financial, diplomatic and political capital.

Dr. Bloeria also pointed out how India has succeeded in establishing closer ties with Afghanistan. A closer strategic partnership with the Afghan National Army (ANA) has been achieved. During President Hamid Karzai's visit to New Delhi on 4th October, 2011, an important decision was taken pertaining to Indian assistance in training, equipping and capacity building of ANA and the police forces. India has departed from its policy in offering to transfer weapons to Afghanistan. India also offered to play a more active role in training the Judiciary, and proposed adopting a strategy to reduce and curb narcotic traffic. It also undertook developmental projects and encouraged the restoration of the traditional elements and power structure within and among the different tribes. India helped in restoring public confidence, opening covert channels of communication with the Taliban and developing strategic partnership with Iran and China. The lecture was followed by a discussion on the issues brought out by Dr. Bloeria.

In his Address, he advised the students to excel in life by not just focusing on academics but also by learning through alternative modes of instruction. He told the students to ask themselves the question: 'What am I doing?' He suggested a formula for success, "Chart a course carefully; never lose focus and do not ever feel disheartened".



Lectures Towards an Understanding of China


March 31, 2012

He said that China is an aberration, There are three approaches to understand itas a civilization, as an empire and as a young nation in the making. While recounting the strengths and weaknesses of China he empasized that the lack of democracy in China had the potential to destabilize it as an economic power. This fault line, if left uncorrected, could lead to the disintegration of China. In his closing comments, Prof. Sharma predicted that India was likely to overtake China by the year 2030.




Musical Morning





जम्मू केंद्रीय विश्वविद्यालय की स्थापना सेंट्रल यूनिवर्सिटिज एक्ट, 2009 (2009 के एक्ट संख्या 25) जिसे केन्द्रीय विश्वविद्यालय (संसोधन) एक्ट, 2009 के साथ पढ़ा जाय, के अंतर्गत हुई है। लेकिन, जम्मू केंद्रीय विश्वविद्यालय वास्तव में अस्तित्व में 8 अगस्त, 2011 को आया, जब इसके प्रथम कुलपति, डा. एस. एस. ब्लोरिया ने कार्यभार संभाला।

जो हाल ही में सेवानिवृत हुए थे। इस समिति कार्य दिशानिर्देश, नियम, कानून तथा शैक्षिक कार्यक्रमों के लिए प्रवेश नियम बनाना था जो शैक्षिक सत्र 2011-12 के लिए लागू होते, साथ ही उनका कार्य शैक्षिक मामलों में उपकुलपित को सलाह देना था।

प्रशासनिक कार्यालय

विश्वविद्यालय ने जुलाई 2009 से अपने प्रशासनिक ब्लाक (37 सी/सी, गांधी नगर, जम्मू) से कार्य करना आरंभ कर दिया, जो उस समय जम्मू व कश्मीर के केंद्रीय विश्वविद्यालय द्वारा किराये पर जम्मू कैंप आफिस के रूप में लिया था।

प्रशासिनक कार्यालय को बाद में बड़ी किराये की इमारत में 1 जनवरी, 2012 को स्थानांतरित किया गया जिसका पता था 8/8, त्रिकुट नगर, जम्मू। प्रशासिनक कार्यालय को पर्याप्त ढंग से सुविधाओं से लेस किया गया है, जैसे कंप्यूटर नेटवर्किंग, फर्नीचर तथा कार्यालय यंत्र आदि।

अस्थायी शैक्षिक ब्लाक-प्रथम

अस्थायी शैक्षिक ब्लाक-प्रथम (TAB-I) जो नरवाल-सिधरा बाइपास रोड, ए-वायरमेंटल पार्क के निकट स्थित है को किराये पर लिया गया तथा यह अक्तूबर 2011 में पूरी तरह कार्यशील हो गया, तथा इसमें तीन शिक्षण विभागों को स्थित कियागया, जो थे डिपार्टमेंट आफ इंगलिश एंड कंपरेटिव लिटरेचर, डिपार्टमेंट आफ एप्लाइड मेथेमेटिक्स तथा डिपार्टमेंअ आफइकनोमिक्स। जो सुविधायें यहां उपलब्ध करायी गयी हैं उनमें सम्मिलित हैं वाइ-फाइ इंटरनेट कनेक्टीविटी के साथ कंप्यूटर लैबोरेटरी, पुस्तकालय, मिनी आडिटोरियम, खेल का मैदान तथा कैफेटिरिया आदि।

केंपस साइट तथा इसका विकास

- राज्य सरकार ने 4880 कैनल 19 मरला (लगभग 600 एकड़) भूमि देने का प्रस्ताव किया है जिसमें 3000 कैनल वनभूमि है, 1254 कैनल 19 मरला राज्य भूमि है, 584 कैनल 6 मरला व्यक्तिगत भूमि है तथा 41 कैनल 19 मरला खाली करवायी गयी भूमि है, जिसपर गांव बागला, जिला सांबा, जम्मू डिवीजन में जम्मू केंद्रीय विश्वविद्यालय की स्थापना होनी हैयह स्थान जम्मू शहर से 25 किमी की दूरी पर है, जो जम्मू व कश्मीर राज्य की शीत राजधानी है तथा यह सांबा के जिला मुख्यालय से 17 किमी की दूरी पर है। निकटतम रेलवे स्टेशन तथा एयरपोर्ट कमश: 20 तथा 25 किमी की दूरी पर हैं।
- राज्य सरकार ने अपने सरकारी आदेश संख्या 340-FST of 2010 दिनांक 27.8.2010 के द्वारा 3000 कैनल वन भूमि के प्रयोग को जम्मू केंद्रीय विश्वविद्यालय की स्थापना के लिए भू प्रयोग परिवर्तन करने को सहमति दे दी है।
- रू. 14.085 करोड़ की राशि को उच्च शिक्षा विभाग, जम्मू व कश्मीर सरकार ने वन विभाग को भूमि
 के मुवायजे के रूप में दे दी है।
- राज्य उच्च शिक्षा विभाग को यह प्रार्थना की गयी है कि वह वन विभाग को क्षितिपूर्ति संबधी वनीकरण के लिए 2.11 करोड़ की राशि निर्गत कर दे।
- जम्मू केंद्रीय विश्वविद्यालय के लिए निश्चित भूमि के अधिग्रहण के सीमांकन को आरंभ कर दिया
 गया है तथा इसके लिए निर्मित दल में राजस्व विभाग, वन विभाग तथा जम्मू केंद्रीय विश्वविद्यालय
 के कंसलटेंट (तैंड मैनेजमेंट) के नेतृत्व में हैं। इस दल की सहायता आवश्यकता पड़ने पर जिला
 सांबा की पुलिस तथा प्रशासन करेंगे।





- एडसिल (इंडिया) लिमिटेड, जो भारत सरकार का संस्थान है, को जम्मू केंद्रीय विश्वविद्यालय के मास्टर प्लान को बनाने के लिए संपर्क किया गया है। विश्वविद्यालय ने साइट प्लान, कंटूर प्लान तथा आर्किटेक्ट के चयन के लिए भी आदेश दे दिया है जो आल इंडिया आर्किटेक्चर कंपीटीशन के माध्यम से विस्तृत योजना तैयार करेंगे।
- कंटूर सर्वेक्षण पिछले महीने किया गया था तथा इसके मई 2012 तक पूरा होने की संभावना है, तथा
 उसके बाद आर्किटेक्चर कंपीटिशन की प्रक्रिया आरंभ होगी।
- चिन्हित स्थान को किसी प्रकार के अतिक्रमण से बचाने के लिए बाउंड्री पिलरों की स्थापना के लिए कार्य को किया गया था तथा इसे अधिकतर परिसर स्थान की बाउंड्री में पहले ही पूरा कर लिया गया है।
- सेंट्रल पिंक्लिक वर्क्स डिपार्टमेंट को प्रस्तावित पिरसर की बाउंड्री दीवार के बनाने के लिए एस्टीमेट बनाने का काम दे दिया गया है।
- राज्य भूमि जिसका माप 1254 कैनल 14 मरला है, अपने अधिकार के लिए राज्य राजस्व विभाग तथा
 वन विभाग के बीच झगड़े की भूमि है। इस मामले को सुलझाने के लिए राज्य सरकार के उच्च अधिकारियों से संपर्क किया गया है।
- राज्य सरकार के उच्च शिक्षा विभाग ने आयुक्त, भूमि अधिग्रहण, सांबा को एक इंडेंट निर्गत किया है तािक उपरोक्त परिसर में स्थित व्यक्तिगत भूमि तथा खाली करवायी जाने वाली भूमि का अधिग्रहण किया जा सके, इसका माप 5 कमश: 584 कैनल 16 मरला तथा 41 कैनल 19 मरला है। राज्य सरकार ने भी भूमि अधिग्रहण के लिए धनरािश को मुवायजे की अदायगी के लिए निर्गत कर दिया है। इस मामले को विश्वविद्यालय अधिकारियों द्वारा उत्साह से किया जा रहा है।
