It was decided that the draft guidelines be put up in the forthcoming Academic Council for discussion and approval.

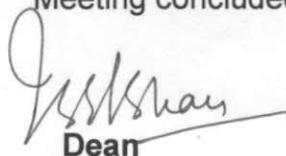

Dr. Suparan Kumar submitted that Mr. Udit Mahajan may contact him on the issue.

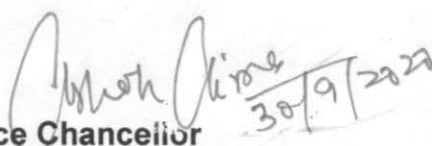
- iv. The Vice Chancellor suggested a dedicated Data Centre shall be created at the campus for the university. He advised the Registrar to issue a notification in this regard.
