### **TERMS AND CONDITIONS FOR DISPOSAL OF OLD VEHICLE**

2. Accordingly, sealed quotations are invited for the disposal of the said vehicles on the terms and conditions mention below. Persons/firms, interesting in purchasing the above mentioned vehicles, may submit their highest quotations in the enclosed Proforma in a sealed cover addressed to the undersigned **latest by 3.00 PM on or before 04.01.2021** at **Office of the Deputy Registrar (GSW), Central University of Jammu, Rahyaa-Suchani, Bagla, Samba -181143**. The bidders or their representatives, not more than one for each quotation, may be present, if they so desired, at the time of opening of Quotations. The cover should be prominently superscripted with the words **“QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE”**.

3. The disposal of vehicle shall be strictly on **“AS IS WHERE IS BASIS”** and no guarantee or certificate of its worthiness or quality will be given by Central University of Jammu. The condition of the vehicle can be inspected physically on **21.12.2020 and 22.12.2020** between 2.30 p.m. to 3.30 p.m at **‘DDE Building’ Central University of Jammu, Rahyaaa- Suchani, Bagla, Samba – (J&K) (Contact Person Mr. Ashish Kumar Singh, Section Officer, GSW, CUJ – Mobile: 9086144877)**. Tender forms with terms and conditions for submitting tenders can be downloaded from University website ([www.cujammu.ac.in](http://www.cujammu.ac.in)) free of cost.

4. The vehicles will be disposed off separately, not through the lot.

5. The quotation should be accompanied by earnest money i.e. **Rs 5,000/-**(Rs. Five thousand only) for each vehicle.. The earnest money can be deposited in the form of Bank Draft/ Pay Order/ CDR/ Bankers Cheque issued in favour of **“Finance Officer, Central University of Jammu”** payable at **Jammu/Samba** (Payment by Cheque/Cash shall not be accepted). The bank draft should be attached with the quotation letter failing which the quotation shall not be

considered at all. If the highest tenderer/successful tenderer accepted by the competent authority in this University fails to deposit the sale price within the prescribed time limit i.e. within 10 working days from the date of intimation to the tenderer(s) declared as highest bidder by the competent authority, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.

6. The bidders are required to pay Earnest Money of **Rs.5,000/-** (Rupees Five Thousand only) for **Mahindra Scorpio** and **Rs.5,000/-** (Rupees Five Thousand only) for **Maruti Sx4 Car**.

7. EMD of the successful bidder(s) will be released only after realization of Sale proceeds amount. Earnest money Deposit of the bidder who fail to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this University. EMD amount of H1 bidder shall be adjusted in the Sale Amount accepted by this competent authority. EMD of unsuccessful bidder(s) shall be released only after successful completion of the sale process.

8. The delivery of the sold vehicle will be arranged by the successful bidder only after the successful bidder submits documentary evidence in support of residential status (Ration Card/ Voters Identity Card etc in case of individual and Registration Certification in case of firms etc.)

9. The sold vehicle will be removed by the successful bidder(s) within 10 days from the date of intimation to the tenderer(s) declared as highest bidder by the competent authority. No assistance/transportation will be provided by the University. Permission to take out the disposed vehicle from premises will not be allowed on holidays, Saturdays and Sundays etc.

10. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. It will be the sole responsibility of the buyer for getting the necessary paper works done in accordance with the law and as per the provisions of the Motor Vehicles Act (amended from time to time) applicable for Transport Authority of UT of Jammu and Kashmir. This office will not be responsible for any lapse on the part of the buyer in this regard.

11. EMD of the firms rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. Decision of the University shall be final in this regard.

12. Central University of Jammu reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.

13. If, the successful bidder wants to scrap the vehicle, then he should have to submit the cut part of the chassis number to this office immediately.

14. EMD of unsuccessful bidder shall be returned maximum within six weeks from the date of declaration of H1 bidder or successful bidder.

15. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number.

16. Disputes, if any, shall be subject to jurisdiction in the Court of Samba only.

17. If the highest quoting firm fails to honour the bid; the contract will be cancelled & its EMD shall be forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete

the bid provided it is prepared to accept the prices offered by the H-I party. In case of any dispute, decision of the University shall be final.

18. Tender form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.

19. Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.

20. The Bid amount is excluding GST, as the GST is to be paid by the recipient of the goods as per the rates applicable.

21. The University Reserve the rights, not to dispose of the vehicle below the reserve price.

22. Quotation should be offered in prescribed tender form as given at **Annexure-1**.
