Expression of Interest (EOI) for Publication of University Books and Journals

On behalf of the Registrar, Central University of Jammu (CUJ), Expression of Interest (EOI) is invited from publishers of academic books and / or journals to publish the books and journals of the University. The publisher will be responsible for the printing, distribution, marketing and selling of these books and journals.

Publishers engaged in the publication of academic books and /or journals with an annual turnover of more than Rs.10.00lakhs per annum in the last three years can apply, offering their terms and conditions. The publisher has to ensure high quality publication in terms of quality of paper, printing, binding, book jacket, design, proof reading and overall book layout as per CUJ norms.

The publication of such books/ Journals shall be in the name of the University and the copyright shall be retained by the 'Central University of Jammu'. The publisher shall be the collaborator 'Publishing House'. The publisher has to also ensure publication adhering to the deadlines specified by the University.

The EOI must be submitted in two sealed envelopes, containing a brief proposal clearly indicating the profile of the publisher, its organisational structure alongwith the availability of in-house facilities for undertaking the task, its experience in publishing academic books/journals, details of the projects undertaken in past five years, qualifications and experience of the team that will be undertaking the task and other details elaborating on its capacity to undertake the work.

Earnest Money Deposit (EMD): Rs.20000/- in the shape of Account Payee Demand Draft favoring **Finance Officer, Central University of Jammu**, payable at Jammu.

(Annexure I). The envelope No. 1 will be superscribed as 'Technical Bid'.



- a) Sealed envelope containing EOI in the prescribed format (Technical & Financial Bid), complete in all respects, duly sealed, signed by authorized signatory and superscribed as EOI for Publication of University Books and Journals alongwith prescribed Earnest Money Deposit (EMD), must be submitted on/before 3.00 PM on 11.09.2018.
- b) The EOI shall be submitted in two sealed envelopes as specified earlier.
- c) All envelopes should be addressed to the 'Registrar, Central University of Jammu'.
- d) Earnest Money Deposit (EMD) of successful bidder will be retained as Performance Security and refunded on satisfactory completion of contract period.
- e) The last date for submission of EOI complete in all respects, duly sealed and signed by the authorized signatory in the office of 'Registrar, Central University of Jammu' in person or through Regd./Speed-Post/Courier is on or before 11.09.2018 at 3.00 PM.
- f) The University will not be responsible for postal or any other delays in receipt of EOIs.
- g) EOIs received after due date/time will not be considered.
- h) No overwriting, corrections or cutting is permitted in the EOI.
- i) Unsealed envelopes or unsigned EOIs will not be considered.
