And whereas it has been stipulated by you in the said contract that the PMC shall furnish you with a bank guarantee by a nationalized bank of good repute and record recognized by you for the sum specified therein as security for compliance with its obligations in accordance with the contract:

And whereas we (Name of the bank with address-----) herein referred to as 'THE BANK' have agreed to give bank guarantee on behalf of the PMC.

We further agree that no change or addition to or other modification of the terms of the contract to be performed there under or of any of the contract documents which may be made between you and the PMC shall in any way release us from any liability under this guarantee and we hereby waive notice of any such change, addition or modification.

Notwithstanding anything contained herein:-

1. Our liability under this Bank Guarantee shall not exceed Rs. 13, 00,000/ (Rupees Thirteen Lakhs)
2. This Bank Guarantee shall be valid upto 15.10.2022.

3. Further a claim period of 2 Months from the expiry date of the Bank Guarantee is available to make a demand under this Bank Guarantee. We are liable to pay the guarantee amount or any part thereof under this Bank Guarantee only and only if you serve upon us a written claim or demand on or before 15.12.2022.

4. At the end of expiry of the validity period unless an action to enforce the claim under this guarantee is initiated before the court or Tribunal on or before 12 Months after the expiry of the validity period all your rights under this Bank Guarantee shall stand extinguished and we shall be relieved and discharged from all our liabilities and obligations under this Bank Guarantee irrespective of return of original Bank Guarantee.
